2. Describe the qualitities of the nominee's design which are considered to have contributed notably to the advancement of the profession:

Mr. Reed has been active in the design of large scale low and moderate cost housing during his entire professional career, and in private practice, beginning in 1957, he has specialized in such projects, all of which bear the mark of being in the vanguard of thinking as regards site and unit planning. His use of simple materials and reliance on mass, proportion, and spacial relationships for the creation of an effective architectural environment is noteworthy.

As an example, the Quintana Project (FHA - Title 234) which consists of 384 units in two tower buildings built around a central plaza, cost only slightly more than \$10,000 per dwelling unit including all electric services and equipment as well as a nursery school and other community facilities. Through-ventilation,

so important to comfort in the Puerto Rican climate, was accomplished without sacrificing low cost by an ingenious system of skip-stop elevators.

The Selles Gardens, public housing project of 300 units, has no through streets, and access to the community building and athletic facilities is possible from all parts of the development without encountering any vehicular traffic. Dwelling units are designed for maximum ventilation, privacy, and tenant maintenance, as well as low cost.

The clean lines of the Commonwealth Housing Center building, and its frank expression of structure used functionally to screen the direct sun, are typical of the nominee's architecture in Puerto Rico.

The El Monte, Urban Renewal Project carried out in collaboration with Edward L. Barnes FAIA, who was primarily responsible for the design, follows the same standards as the projects referred to above. It was the first Urban Renewal Project in Puerto Rico and has received several national and local awards.

For many years prior to the founding of the Puerto Rico Chapter, the nominee encouraged young architects working in his office to join the AIA by acquainting them with the advantages and responsibilities of membership, the AIA documents and publications and assisting them in the payment of dues.

He has been active in Chapter affairs ever since its founding. He has provided leadership in the Chapter's opposition to the imposition on architects of responsibilities for certification of construction having legal and liability connotations far above normal supervision, and he is currently active in this campaign.

As a member of the Citizens' Committee of the Nuevo Centro de San Juan, Mr. Reed has been active in presenting the technical aspects of the new center for metropolitan San Juan to the public and the Legislature, and in the fund raising campaign which totaled \$300,000. He participated in the founding of the Citizens' Committee and has contributed to its policy decisions throughout its two years of existence. He and Osvaldo Toro FAIA are the only architects on the Committee.

The nominee was a member of the Mayor of San Juan's Committee of citizens to evaluate planning, social, and economic programs in the community from 1966 until 1968.

The Casa del Libro in Old San Juan is a library of fine books dedicated to improvement of the quality of printing and to cultural advancement in Puerto Rico. As a member of its Council, Mr. Reed has assisted in membership and fund raising drives, and is presently active in advising the Council on the technical aspects of expanding its physical facilities.

The nominee has been a Director of the National Housing Conference for a number of years, and a member for 35 years. This organization is dedicated to formulating national housing policy and appearing before Congressional committees in the public interest in relation to housing legislation and appropriations. He has represented Puerto Rico at numerous national meetings.

As a Director of the Puerto Rico Orchid Society, the nominee has assisted in the preparation of orchid shows in San Juan, and in the business aspects of the Society.

Mr. Reed was a member of the Governor's Committee to revise the Building Code of Puerto Rico, and participated in the numerous meetings and discussions involved, for nearly two years.

2. Describe nominee's achievements in urban design which are considered to have contributed notably to the advancement of the profession:

As a member of the Urban Design Committee of the Puerto Rico Chapter, Mr. Reed has been active in the development of the concept and technical studies made for a new center for Metropolitan San Juan on land being transferred by the Federal Government to the Commonwealth. The work of the Committee first consisted of the evolution of a basic plan and model used to gain public and government interest in the exceptional opportunity that exists to create a new heart of the city on land which is almost completely vacant. Later, after funds had been raised and a technical staff with paid consultants established, the Urban Design Committee has acted as advisor to the technical staff through meetings held almost weekly over a period of more than 18 months.

However, prior to the formation of the AIA Chapter in Puerto Rico Mr. Reed was active as an individual architect and planner in calling the attention of the Government and community leaders to the necessity of developing a new center of the city in the Hato Rey area. His initial study, listed below, was prepared in 1958 in collaboration with an economist, and presented as a public service to the Planning Board of Puerto Rico, in an effort to draw attention to the potential that existed to create a new center for the city on land that was essentially vacant and unplanned. Two years later, in 1960, Mr. Reed prepared a brochure containing a study of the area in more graphic detail, which was circulated in business and Government circles, again calling the attention of the Government to the trend of development of the city and the exceptional opportunity existing.

In 1961 Mr. Reed's office prepared a master plan for the Quintana area of Rio Piedras consisting of 650 acres of urban land, formerly occupied by a race track and neighboring areas. The plan established the principles of reducing vehicular through-traffic, integration of high rise and low rise housing, commercial facilities, and park and school areas, the creation of an urban environment not dominated by the automobile. (See exhibit No. 10)

The design for an addition to the town of Carolina, Puerto Rico was prepared in 1962 for the Puerto Rico Urban Renewal and Housing Corporation. It integrates the existing town with the "new" area by the development of a new town center with satellite neighborhoods. The plan has not yet been implemented due to lack of funds for flood control of the area.

2. Describe the specific achievements of the nominee in various positions in government or industry which have contributed notably to the advancement of the profession:

Mr. Reed's professional career in government and industry has been largely devoted to planning, design, and the development of large-scale low cost housing projects, and the development of design standards and construction methods. He has studied extensively building methods and materials in Europe both as Consultant to the Public Works Administration, where his work resulted in a report on housing programs and techniques in a number of countries, and as a member of President Roosevelt's three-man Special Housing Mission to Great Britain in 1942. The latter entailed investigation of emergency housing for war workers in Great Britain. Mr. Reed was in charge of all technical investigations.

Mr. Reed returned from England to work on the organization of the Technical Division of the National Housing Agency and became its Chief of Housing Standards. After three years' service in the Marine Corps he was appointed Deputy Housing Expediter and Director of the Technical Office responsible for final technical review of all applications for financial assistance from companies producing industrialized housing and building materials, and for administering a Research Fund of \$750,000 for the study of building materials and processes. He initiated an extensive research program in the field of lightweight concrete aggregates which was carried out by the scientists at the Bureau of Standards and the Bureau of Reclamation. Mr. Reed also directed the development of Performance Standards for Residential Construction, the first published set of criteria establishing housing standards on a performance rather than a specification basis - an important step toward the modernization of building codes. A Plumbing Code for housing which freed the building industry of many obsolete and expensive practices was developed under his direction as a project at the Bureau of Standards.

In 1947 the nominee became the Vice-President of Southern California Homes, Inc., where he combined his technical knowledge of materials and processes in the supervision of design and the production of a prototype house for large-scale production involving engineering and design techniques developed in the airplane industry. He also designed and supervised the manufacture of a housing structure for the U.S. Navy built of aluminum-faced honey-comb core panels to be used in the Arctic under the most severe weather, erection, and transportation conditions.

As Vice-President and a Director of the IBEC Housing Corporation (a subsidiary of the International Basic Economy Corporation), Mr. Reed was a major contributor to the development of the IBEC Method of Low Cost Housing Construction, and was responsible for the project which first tested it on a large scale. Later he directed the IBEC Housing Program in Puerto Rico, which resulted in refinement of the method, further rationalization of construction processes, and the building of thousands of low cost homes of reinforced concrete construction.

Mr. Reed served as a consultant to the National Security Resources Board while an officer of the IBEC Housing Corporation. He produced a comprehensive report on "Housing Problems in Post-Attack Industrial Rehabilitation" and two additional studies on national security as affected by the vulnerability of urban areas, and by this country's activities and policies in connection with housing and community facilities.

"The Case for Factory Made Housing," was the lead-off for a symposium on the subject of prefabrication. It is an analysis of the antiquated processes of the home construction industry and a resumé of the potential benefits of rationalization of building processes.

"The Best Investment in the World" analyzes the problem of providing adequate housing throughout the world in terms of financial measures. It suggests the creation of a "World Housing Bank" operating with guarantees from member nations and bonds in a manner similar to the International Bank. In individual countries the system would operate like the FHA in the United States, but with international guarantees and standards of design and construction related to local customs and requirements. The idea was later adopted by the Alliance for Progress for its housing program in Latin American countries.

Resumé of "New Homes for Old"

"New Homes for Old" is one of a series of "Headline Books" published by the Foreign Policy Association of New York. Printed in 1940, it outlines the housing problems existing in the United States at that time and points to the advantages of reviewing European experience after World War I in attacking the problems of slum clearance, housing, and urban development.

It explains, in layman's terms, the problems of environment generated by the move to the cities which started with the industrial revolution. It traces the development of city planning in England and the techniques of land planning and development that are the basis of much of the better urban planning today. It discusses standards of design and construction.

The book then takes the reader for a brief inspection tour of housing in England, France, Austria, Germany, Sweden, and Holland pointing out the financial, social, and design aspects of each program that might have applicability in the United States. It ends with a discussion of the magnitude of the housing problem and suggestions regarding a program which, had it been followed, might now find us much closer than we are to our objective of a decent urban environment for everyone.
