His ability in Design is especially noteworthy and he has brought to his major commercial and public projects the same lightness and freshness which distinguishes his residential work. He has retained dignity and prestige for his bank work but has completely discarded aloofness and austerity.

Mr. Reeder has a fine record of Institute activities, both local and national. He served with distinction as Convention Chairman for his A. I. A. district and it was during his term as President of the Florida South Chapter that the program of Craftmanship Awards was inaugurated.

His Public Service record is equally impressive as he has served in many capacities. It should be especially noted that his service has included such hard work assignments as Code Revisions and Contractor's Examining Boards. However, Mr. Reeder has widely divergent interests and his participation in Fine Arts activities has been particularly noteworthy.

Mr. Reeder's major designs are well known and his Industrial National Bank, Miami Beach Federal, State Hospital and his other public works have reflected greatly to his credit. His lesser work gives equally as much pleasure. The careful attention to detail, the good taste in material and texture so obvious in his residential work and in the exquisite Carolina Mirror exhibit, mark him as a master designer.

Mr. Reeder will be a creditable addition to the group of Fellows of the American Institute of Architects.



It has been my honor and privilege to work with Mr. Reeder on a number of different civic enterprises. Beginning in 1946, he accepted a seat on the Building Officials Committee of South Florida, of which I was Chairman. During his 10 years of service on the Committee, as one of the representatives of the Architectural profession, we recommended revisions to the City of Miami Building Code, which were adopted, and our Committee was instrumental in obtaining the adoption by all of the Dade County Municipalities west of Biscayne Bay, and the unincorporated area of Dade County, of this revised and more or less up-to-date Code on a uniform use basis.

Work of the Building Officials Committee was constant over the entire 10 year period, and Mr. Reeder, as well as the other members, worked diligently on such items as setting up standards for the handling of redimixed concrete, standards for welding and in the investigation of new materials as developed.

In 1955, the Dade County League of Municipalities with assistance from the then Dade County Board of County Commissioners appointed a Committee known as the Building Code Steering Committee, for the purpose of writing and compiling a completely new building code. They appropriated a small amount of money for the payment of incidental and secretarial help only. As Chairman of this Committee, I realized the necessity of organizing a Technical Committee which would be not only qualified for the job at hand, but would be willing to


