We nominate CHARLES T. PEARSON, A.I.A. for his everconscious efforts and concern for the legislative well-being of his Chapter, and his desire as Editor of our Chapter Bulletin to keep every member well informed on all matters that contribute to their professional knowledge and stature.

In the matter of legislative activities, he has been a member of his respective Chapters' Legislative Committee every year since 1941 — the year that he became a corporate member assigned to the Washington State Chapter (now the Seattle Chapter). Then, and since the formation of the Southwest Washington Chapter, Inc., every session of the State Legislature has found him at the State Capitol working to protect our professional interests, and to improve our Registration Law. In the 1930's, 1940's and early 1950's it was with heartbreaking results, but finally in 1959 the State Legislative Committee was successful in having our Registration Law revised and up-dated. One of the major contributions to the 1959 success was Charles' persistant "leg-work" and dedication to the missions success.

Having been a major contributor to the Washington State Chapter Bulletin, prior to our Chapter being granted a Charter, it was altogether fitting that the first Executive Committee of our Chapter request our nominee to be the Editor of our Bulletin. He accepted the task without hesitation, and our monthly bulletins have been an instrument of great professional value to all our members, our younger members in particular. He attends all our Regional Conferences, State Council meetings and Chapter meetings and reports on these activities with clarity and interest.

The true value of his continued high level participation and contribution is difficult to express in words, but we feel that through his sustained dedication to the correction of our professional legislative problems, and his ability, through our bulletin, to create an informed profession within our Chapter limits, Charles is serving the Institute in a manner worthy of our highest consideration.

A. A. CLEVELAND CONFERENCE:

Just as we suspected, everyone thinks this one was in Cleveland. As a matter of fact, the Cleveland Conference, held at Washington State <u>University</u> in Pullman during July 19-20-21, was named for a man who was formerly with the College of Education at W. S. U. The College of Education has sponsored meetings each summer on various phases of education, aiming these meetings at administrators and school people. This year, through the suggestions of Bob Darlington and his cohorts in the Department of Architectural Engineering, the Cleveland Conference was devoted to school buildings.

The featured keynoter was William Caudill, one of our outstanding school architects, and various members of our three Chapters

served to spark discussion groups. Several other members, including Bob Price of our Chapter, Ken Brooks of Spokane and Harry Weller of W. S. U., did yeoman service as featured panelists or speakers.

We found this to be a very fine session, in spite of 104-degree temperature, and Bill Caudill was terrific. His participation made a great impression and he was ably aided by Armold Tjomsland of the State Department of Education. Our Chapter can be proud of the part played by Bob Price in making this an outstanding affair. Ask Bob to give the definition of the relationship of the architect to the school administrator, from the gospel according to Caudill. Sorry we can't print it here.

Our only gripe was the apparent lack of information given out to many architects who we know would have wanted to attend.

NOTE FROM THE EXECUTIVE BOARD:

At their next meeting, the Executive Board will discuss the enforcement of Article 4, Section 3, paragraphs B and C of the Advisory Form of Chapter By-Laws, revised edition of 1955, which provides that Junior Associates shall be moved up as the Executive Committee feels they are qualified.

The Executive Board will make it a point to determine who is qualified, and automatically move them up.

SUNSET WESTERN HOME AWARDS PROGRAM:

The Tacoma home of Mr. and Mrs. Karl F. Daviscourt, designed by Robert Billsbrough Price, A.I.A., is the winner of one of the top five Honor Awards in the second bienniel Western Home Awards program, the Awards Committee had announced.

In this year's program, co-sponsored by the American Institute of Architects and Sunset Magazine, the Awards Jury granted a total of thirty Honor Awards, Awards of Merit and Special Awards. The program is designed to draw public attention to outstanding examples of Western architecture, and the winning homes were selected from over 200 entries submitted by architects in the 11 Western states and Hawaii. Lawrence W. Lane, Sr., publisher of Sunset, and A.I.A. President John Noble Richards will present the awards to winning architects at the Pacific Rim Architectural Conference in Honolulu October 7-14.

The award-winning Tacoma home, built as a speculative house by Stromberg Construction Company, was praised by the Awards Jury for its plan and for its neat detailing. Each indoor area has a matching garden, so that indoor and outdoor areas work together with exceptional smoothness. The dining area has a matching dining terrace. Off the bedrooms is a play terrace; and off the family and living rooms is a living terrace close by the house, plus a second pergola-sheltered terrace in the rear yard.

The Tacoma house is one of two winners from Washington State. A Special Award, granted by the jury for "the noteworthy solution of a special problem", was won by Architect Wendell H. Lovett of Bellevue, for an experimental design house custom-built in Bellevue for T. Gervais Reed.

The award winners will be announced in the October Sunset, and the winning homes featured in that and subsequent issues. Special exhibits of photographs and plans will also go on display in the following cities:

Somewhere in all this there is the intent of an apology and we have a feeling that we will get in deeper if we carry it on any farther.

THE OLYMPIA MEETING:

Last month's meeting was a little sparse on attendance, but that is the story of our life.

The Program Committee had set up the panel for a discussion of ethics and the understanding of same, which turned out to be very lively indeed. Frank Baker, attorney, gave a lot of good sound discussion on this nebulous subject and he was followed by Don Burr, Don Seifert and Bob Wohleb. Bob wound it up in a blaze of glory from which came considerable floor discussion. As a matter of fact, we are sure the discussion could have gone on until morning, and it was stimulating to say the least. We won't try to review it here as it was being taped, and even if the tape got slightly incandescent at times it is available through the Chapter for bull sessions.

As a result of the taping of this one, it seems to have become the order of the day, and the program of the November meeting will also be taped, so the participants may bear this in mind. We can always go back and determine if the individual did or did not say what he claims he did or did not say.

WASHINGTON STATE COUNCIL OF ARCHITECTS, A.I.A.:

Comments have been received from quite a number of people regarding the first draft of the Council structure, and the changes suggested have been few indeed. The various comments were distributed to all of the Committee members and to the Presidents and First Vice Presidents of the three Chapters. However, there is general concurrence in the scheme.

The Spokane Chapter has ratified the draft and, from what Dick Eddy tells us, it was unanimous.

Bob Durham commented on it very favorably in a letter recently received, and he thought that this represented the beginning of a fine professional relationship in the State.

Our Chapter can ratify the substance of the draft, although we have to have a notification period before adopting an assessment for this Council, since such items are changes in the by-laws.

Larry Waldron says that the Washington State Chapter Executive Board has recommended the adoption of the Council, although they think the financing of it should be reviewed soon because they don't believe the \$5.00 assessment will cover the necessary expense. Such a review would, of course, require the concurrence of all three Chapters.

CHAPTER BULLETINS:

Bob Durham asked questions in Spokane about the various Chapter Bulletins and showed samples of some from other areas which were actually journals, with advertising, photography, etc., printed on very good paper. He wondered if Chapter Bulletins should get into this much of a publication or if a bulletin such as ours is a more personal and informative sheet. He was very complimentary about the Southwest Washington Chapter's Bulletin and had only a few suggestions. These we think are valid but they will require the help of Committee Chairmen as well as Officers and Board. He mentioned the reports of the Washington State Chapter Professional Practice Committee in reviewing various typical cases of infraction, with the thought of educating the membership by, as he says, "gradual absorption".

COLOR SLIDES AND MOVIES:

Bob Durham mentioned that he would like to attend one or more of our meetings and, if we would schedule it, show his slides of the Brussels Fair. We haven't seen these but have seen quite a few of his slides. Bob's manner of presentation is excellent and his pictures have a wonderful quality which we highly recommend. Program Committee take note.

We recently received an announcement from the Octagon concerning the availability of a 13-1/2 minute color film entitled "Designing a Better Tomorrow - A Career in Architecture". This is a semi-animated color film and the announcement says it is the best one so far. It is designed for showing to high school and junior high school groups, preferably at the 8th, 9th and 10th grade levels. Apparently this is also a good short course on the meaning of architecture in general and could be shown to

civic, service and other groups. It should be used as a speaker's aid, followed by a question and answer period. It is cleared and suitable for television use. Our Chapter purchased a film some time ago - "A School for Johnny", and our suggestion is to send for this one on a rental basis with option to purchase.

WASHINGTON SOCIETY OF PROFESSIONAL ENGINEERS' CONFERENCE:

We attended some of the sessions of the recent W.S.P.E. Conference in Tacoma and found that the substance of their discussions and their problems have a very familiar ring. At the Engineers in Private Practice Luncheon the discussion revolved around Architect-Engineer contracts and fees. We know that we have good attendance when the latter is up for discussion. Our comments at the meeting were basically a request for their help and cooperation in getting our own fees up to a reasonable level, especially in school work. A request for help in this line probably should be based on the assumption that there is a reasonable amount of hope that the school fee situation can be improved. Our closing remark, we hope, removed any doubt that such an improvement can be easily accomplished, if at all.

ITEMS FROM BULLETIN OF WASHINGTON STATE CHAPTER:

The Washington State Chapter Executive Committee has endorsed the idea of adoption of a master specification index by local architects. Its use would involve very little change for any office but would be a great convenience to subs in take-off work, allowing them always to find their material in the same division of the specs. Copies of the Index, as developed by the Puget Sound Chapter of the Construction Specifications Institute, will be sent each office for its use.

The A.G.C. in Seattle has again expressed concern over not having enough plans for subcontractors to work with during bidding. In the past 10 years there has been more than a 100% increase in membership in the Seattle Construction Council to a present membership of 470. Consequently, many more subs and suppliers are making use of the plans filed with the A.G.C. Their request is for 2 sets minimum on every job and 4 sets on jobs running over \$250,000 unless of the simplest building type. Greatest activity is on the later part of the bidding period, of course. Therefore, if there are turn-backs by some who decide not to bid, best use of them can be made at the A.G.C., the only non-profit plan service in town. There is no doubt that this applies in all A.G.C. offices.

BEWARE! Confidence man with a stute architectural background may be operating in the Seattle area. (We are indebted to the Spokane Chapter, in whose area he was active last month, for this information.)

He speaks very intelligently - claims to be writing book on Italian culture, is alternately from Mexico and Italy. Apparent motive - to "borrow" money. Known aliases - Wayne Robinson and Barney Bates.

Congratulations to the Pacific Northwest Chapter of the American Society of Landscape Architects, organized last month in a meeting at Portland. The newly-formed Chapter includes eligible landscape architects in Oregon, Washington, Idaho, Montana and Alaska. Miss Roberta Wightman of Seattle was elected first president, and Arthur L. McLish of Bellevue, secretary. Other officers and committee appointments represent the remainder of the new Chapter's region.

SPOKANE CHAPTER:

The Spokane Chapter is inaugurating an annual program of Honor Awards for current work. Awards will be made for distinguished accomplishments in architecture by a Spokane Chapter Architect for any building completed since 1955.

FROM THE OCTAGON:

Washington, D. C. -- "Retained percentage" procedures on construction contracts were the subject of a day-long discussion November 5th, between architects, subcontractors, producers and surety bond experts at The Octagon, Washington, D. C. headquarters of The American Institute of Architects. The meeting was called on the invitation of AIA, which was represented by six national officers and directors as well as the chairmen of national AIA committees concerned with construction industry problems. AIA President John Noble Richards, FAIA, chaired the meeting. Representatives of twelve national subcontractor organizations and building product companies, as well as of the Producers' Council and the Association of Casualty & Surety Companies, The Surety Association of America and the National Association of Credit Management and Dr. Robinson Newcomb, noted Washington D. C. economist, participated in the deliberations.

The purpose of the meeting was to acquaint the officers and regional directors of AIA with the subcontractors' problems and views on "retained percentages", the amounts withheld from payment on any job as a protective cushion to assure completion of a job according to owner's and architect's specifications. The subcontractors pointed out that there are wide variations throughout the industry and the nation in retained percentage procedures, both on private works and on state and public works.

I. NAME

Washington State Council of Architects, A. I. A.

II. STRUCTURE

To study all legislation affecting the architectural profession and report to the Council the findings; to give leadership in blocking adverse legislation and to take steps to work toward the passage of legislation to strengthen the laws covering the profession and the building construction industry.

- 2. State Administration Sub-Committee

 To provide liason between the profession and the various departments of the State, Federal Government, etc.
- 3. State Inter-Chapter Affairs Sub-Committee

 Established to continue the excellent relationship existing between
 the three Chapters and to act as a clearing-house for inter-chapter
 activities, except that the authority of the Council shall not supersede that of the individual Chapter.

The Chairman of each sub-committee will be appointed by the Council Chairman annually from sub-committee membership. The Secretary of each sub-committee shall be appointed by the Sub-Committee Chairman, except that in no case shall an officer of the overall Council serve as Chairman or Secretary of any sub-committee.

VIII. CONDUCT OF MEETINGS

Conduct shall follow Roberts Rules of Order.

IX. QUORUM

A quorum of the Council shall be seven members.

X. OPERATIONAL FUNDS

- 1. The fund shall be increased on the basis of an annual rate of \$5.00 per Corporate and Associate Member of each Chapter residing in the State of Washington, exempting only those who are retired or are in the Armed Forces.
- 2. The method of securing operational funds shall be at Chapter option, either directly from the Chapter Treasury or as an assessment of the members.
- 3. The fund shall cover all expenses incurred by the Council and its sub-committees, for travel, subsistence, clerical work, supplies, etc., in executing the work of the Council.
- 4. The fund shall be collected for a period of four years from the time of adoption by the Chapters. At the end of four years, the fund will be reviewed and adjusted as experience indicates, and re-submitted to the Chapters for approval.
- 5. The Annual Council Report to the Chapters shall include the financial report and statement.

This event could offer a unique opportunity to re-interpret the too-little known privileges of museum or gallery collections as to uses, sales, bibliography, etc. Where there is no library, selected reading lists, - referring to the specific objectives of the specific gallery, - could have great merit to an investing public.

GASTON C. LANCE, A.I.A. - - 1877 - 1964:

Gaston Lance, former partner in the firm of Lance, McGuire & Muri, died at home early this month.

He was born in Bucharest, Romania of French parents. Following the death of his father when he was 12, he worked in a store while attending evening school to learn drawing and modeling.

He worked in many countries during his youth. He worked as a machinist and later as a salesman for wood working tools in much of Europe.

Married at the turn of the century he went to Barcelona and from there they traveled thru the Mediterranian area where he learned several languages. He taught French in the evenings.

They spent some time in London where he became a mechanic in the newly organized automotive field.

He helped publish Italian and French weekly newspapers.

ASTON C. LANCE:

He came to the Seattle-Tacoma area during the Alaska Yukon Exposition and decided to remain here. He bought a carpenter shop on St. Helens Avenue in 1921 and lived at Lakebay while designing and building boats at Gig Harbor.

When Tacoma went into the Moving Picture business at Titlow Beachs' Weaver Studios, Mr. Lance was made an Art Director and could have gone to Hollywood on a contract but for the illness of Mrs. Lance.

He met A. J. Russell, one of the pioneer Architects in Tacoma and this led to an association which lasted until Mr. Russells' death.

He later associated with Irvin Muri and following World War II the firm became Lance, McGuire & Muri in which he was active until some years ago.

All thru his career he was interested in his profession and in writing. Many of his writings have been published and we have some of this material covering the history of draftsmanship and many other interesting studies he had made in certain fields of Architecture.

With his many years of interest in Architecture and his loyal attendance at meetings until his disability prevented it, We Will Miss This Enthusiastic And Friendly Man!

EDMUND RANDOLPH PURVES, F.A.I.A.:

Early this month we were notified of the passing of Ned Purves who for many years was Executive Director of the Institute.

The list of services to his profession and general achievement are very extensive. He served his country with valor during both World Wars and was decorated by his own and other governments.

His formal education in Architecture was with the University of Pennsylvania, followed by study abroad.

He served on many commissions and committees and crowded many more years than the actual 66 into his active career.

STATE DEPARTMENT OF PUBLIC INSTRUCTION:

The following regulation has been retained by Mr. Bruno's office after efforts to change it by the A.G.C. as well as many of the Architects:

"Whenever the estimated cost of a project exceeds \$100,000, separate bids shall be received for general construction, mechanical work and electrical work. A combined bid for all of the above mentioned work may be received provided such combined bid is in addition to the separate bids. Separate contracts or a contract for construction of the entire project may be awarded on the basis of whichever is most advantageous to the school district and to the State in accordance with bids received".

OM THE OFFICE OF STATE FIRE MARSHAL:

Re: Approved 45 Minute Wooden Doors

"The Uniform Building Code calls for 45-minute doors for various institutional occupancies (e.g. hospitals, nursing homes), subject to the jurisdiction of this office. We have always accepted solid core wooden doors as meeting this requirement. However, it has come to our attention that many such solid core doors being sold in the State of Washington are of inferior type, and should not be considered to meet the 45-minute requirement.

Therefore, this office will consider solid core doors to meet the 45-minute requirement only if one of the two following conditions exist:

- 1. The door bears the appropriate label of the National Board of Fire Underwriters, or
- 2. The door has been inspected and tested by a reliable independent testing agency. Such test must be witnessed by a representative of this office, and two copies of the certification of the test must be forwarded to this office. In addition, the manufacturer shall be required to file with this office, as to each construction job, its certificate of warranty that each door provided meets the requirements of this office.

Door jambs and latching hardware. Door jambs shall be of steel of the required gauge, or if of wood, shall be cut from nominal full 2" stock, with stops which shall be rabbeted of not less than 5/8" thickness. Latching hardware shall be of the cylindrical type set in tight fitting holes. Mortised type latches are not acceptable."
