Dear Alex:

I am pleased to give you what information I have concerning our Chapter's nominee for Fellowship, Mr. Louis Rossetti.

The name of his firm is Giffels and Vallet, Inc., L. Rossetti, Associated Engineers and Architects. Both Giffels and Vallet are registered professional engineers.

As chairman of our joint registration board, I can state that an engineer can do anything legally that an architect can, except call himself architect. Further, our Act permits corporations to practice architecture and/or engineering, and all of our large offices are incorporated.

Form this, it can be seen that Mr. Rossetti is not entirely responsible for the actions of his firm, but this does not excuse him in the event of the firm's misconduct. While membership in The Institute is by individuals, we hold such members accountable to see that their firms practice properly. The point I desire to make is that there is a difference in the engineer's ethical viewpoint and that of the architect, and this is supported by law.

There may be some Institute members in our State who question the propriety of an architect lending himself to a firm that is predominently engineers, or to the firm furnishing so-called "package service," but perhaps they overlook the fact that the law provides for such firms and there isn't much we can do about it.

I do not mean to imply that Giffels & Vallet are in a class with the "package" firms. They are strictly professional and highly regarded, just as are the firms of Albert Kahn, Inc.; Smith, Hinchman & Trylls, Inc., and others made up principally of engineers.



Perhaps those in a position to know best are officers and directors of our Chapter, for they receive complaints of malpractice. There have come to this office three this week, but I can state all are from architects who did not get jobs they thought they should have.

Mr. Rossetti is a director of the Chapter Board at present, and, to my knowledge, there has never been any charge of unprofessional conduct against him or his firm.

Dear Alex:

I should like to supplement my letter of yesterday concerning Louis Rossetti.

While he is not in a policy-making position with his firm, he does advise the other partners, from his own knowledge of Institute rules, and through Arthur K. Hyde, FAIA, a staff architect. One of Art's duties is to answer for the firm such questions as have to do with architectural practice. Art calls me regularly to verify certain provisions of certain Institute documents, and he is not one to compromise on matters of practice. He hughs to the line and whatever his advice to his firm it is followed to the letter.

A recent example:

The firm did an addition to the Grand Rapids Press. The newspaper was very proud, and issued a special edition featuring the new building. The paper asked the architects to take space, and while the firm wanted to cooperate, upon Art's investigation and report, it was necessary to inform the clients that, according to mandatory rules of the Institute, there was no way possible - no matter what copy was used in such an ad.

Arthur Hyde is a former partner of Jack Williams, now in your office, and Jack too was with G. & V. before going to Cleveland. I am sure that he knows Louis Rossetti is not unethical.

Giffels & Vallet did a factory in Grand Rapids. Ordinarily this might cause some friction, but members of the Western Michigan Chapter invited the firm to enter the building in their honor awards. They did and won first prize in the industrial class.

The firm is one of the largest in the world. Recently it was given the largest architect-engineer contracts ever awarded by the Government or any others - the atomic energy plants, costing more than a billion dollars. The firm has more than a thousand men in the Detroit office alone, and as many more in their field offices. Such a firm does not have to use questionable practices to obtain work. Work seeks them.

Naturally, a firm doing such a volume of work is bound to incur some ill will from other architects who were unsuccessful applicants for commissions, but it my belief that the firm of Giffels & Vallet have set an outstanding example of fair practice.

My dear Alex:

Talmage C. Hughes has asked me to write to you and I am always glad to write you under any pretext but would be even happier to have a visit with you.

Talmage is disturbed because of an intimation by someone that Louis Rosetti might have been guilty of some impropriety with his practice for Giffels & Vallet and because they have done two jobs in Grand Rapids, he asked me to tell you what I know about them.

The first project they did in Grand Rapids was a Bakery Plant and they were asked to enter this building in the Western Michigan Chapter's Competition last year and it received the honor award in its class. Recently, they have completed an addition and modernization of The Grand Rapids Press Building (the newspaper for which I write a column) and I talked to Mr. Lee M. Woodruff, Editor of The Press regarding their work on this job. Mr. Woodruff tells me that he was in contact with Mr. Rosetti as consultant in regard to the selection of color schemes, furniture, etc., and found him extremely cooperative as was every member of the firm.

I am completely at a loss to know where anyone would get the idea that Louis Rosetti, or the firm with whom he is connected, has ever conducted their practice in an improper manner. I was in direct competition with them some years ago to obtain the architectural work for Ferris Institute at Big Rapids, Michigan, a State College, but inasmuch as my vocabulary outlasted theirs (as you know to your sorrow my vocabulary outlasts practically anyones) I got the job. Their conduct on this job was entirely correct in every particular.

I am convinced that there must be some mistake as Louis Rosetti and his firm have always enjoyed a very high reputation in the State of Michigan.

Are you going out to the Convention at Seattle in June? I hope to fly out there for the Convention with Gus Langius of Lansing, Michigan, who is to be made a Fellow. I was nominated by the Chapter for a Fellowship but withdrew inasmuch as we already had two candidates, Ken Welch, and Gus Langius, and it seemed improbable to me that we needed three.
