He was elected Secretary for the Chapter in 1933, serving for 4 years, and Vice-President for 3 years.

During the period from 1943 to 1946 he was with the Armed Services ending with the rank of Lieutenant Colonel as Deputy Engineer, Western Pacific.

On his return he was elected President of the Chapter.

He was a member of the Executive Committee for 12 years, including the years in which he held office.

In 1940 to 1942 he was a member of the Institute Committee on Allied Arts.

In 1954, a member of the A.I.A. Board of Examiners.

In 1948, the Rhode Island representative on the Joint Committee which wrote the original New England "Blue Book", establishing the first schedule of uniform fees in New England.

From 1949 to 1955, Chairman of the R. I. Chapter's Office Practice Committee.

In 1955, became Vice-Chairman, New England Region A.I.A. Committee on Office Practice.

The period since 1949 has been devoted to the effort of holding the New England States together, maintaining the standards established by the "Blue Book".

1953 and 1954, member of a Visiting Committee of the National Architectural Accrediting Board.

The Executive Committee feels that through Mr. Geddes' long and almost continuous service to the A.I.A. he has been a helpful and guiding example to the new and younger members during a period of rapid Chapter growth.

Gentlemen:

As a member of the Executive Committee of the Rhode Island Chapter, I should like to endorse the nomination of Peter Geddes for Fellowship in the American Institute of Architects for achievement in Design and Service to The Institute.

Mr. Geddes has designed a wide variety of buildings from residences to bank and office buildings. From my observation, he has always been able to develop in his buildings the feeling of unity which exemplifies good design. worked with different materials and different techniques of building construction, and he has used them appropriately. His feeling for scale is splendid, not only in relation to materials but in relation to the human proportions. Mr. Geddes has used new techniques of construction, such as the pre-cast panel type in the dormitiries at Rhode Island University and the lift-slab method in several of his schools, and he has used them not just as experiments but because these types of construction suited the structures to be built. Further, the unique quality of the construction is expressed in the completed work.

In the Old Stone Bank Building, Mr. Geddes has produced an exceptionally handsome building - unified, harmonious, in good scale, and made of appropriate materials. This stone and glass building seems to grow old graciously - will have a lasting quality which so many contemporary works lack. Deterioration so frequently sets in with age.

Mr. Geddes'plans are simple, direct, and functional. The interior of the buildings have been as well studied as the exteriors, the details have been carefully considered, and a pleasing harmony has been obtained between the inside and the outside.

Mr. Geddes has done some of the best work in this area, and I believe that this work reveals an exceptionally fine feeling for architectural design.

Mr. Geddes has been very active in Chapter and National Institute affairs since 1933. He has served the local Chapter as President, Vice-President, and Secretary, and he was a member of the Chapter Executive Committee for twelve years. Gentlemen:

As a member of the Executive Committee of the Rhode Island Chapter, American Institute of Architects, I was privileged to take part in the nomination of Peter Geddes for fellowship in the Institute.

I have known Peter Geddes for over twenty years. He was my first employer. As an architectural student, during a one-week vacation, he assigned me the task of preparing preliminary studies for a small house. With no outward indication of his irritation, he was successful in modifying what the stubborn idealistic student had overbearingly (I'm afraid) insisted was a simple inexpensive design. I tell this because it is typical of Peter's understanding, tact and diplomacy.

Peter has made a notable contribution to Rhode Island architecture. His design has an unselfconscious simplicity coupled with a unique charm which display an intuitive mastery of his art.

The two qualities in Peter's work which seem most characteristic are its friendliness and lack of ostentation. Although his work is thoroughly up-to-date, he is sensitive to those qualities of the old which we associate with its vitality.

His dormitories at the University of Rhode Island are a good example of what I am trying to say. Their scale is properly residential. The dormitories are well proportioned in mass and in the relationship of the parts. Important design details have not been overlooked. The sash are placed very close to the face of the brickwork, giving a light, airy

effect. The belt coursing is subtle and effective. There is a pleasant textural contrast between the rough brickwork and reflective glass, and the pattern of the open awning type windows casting shadows against the brick is extremely attractive. The informal relationship of the dormitories to the site is particularly charming.

Another example of Peter's work, which I think emphasizes this unpretentious quality, is the Branch Bank for the Providence Institution for Savings (Old Stone Bank) in Providence. This dignified but intimate building almost literally reaches out and invites you in. Here again, the relationship of the building to the surroundings is especially effective. The bank has a quiet charm which is enhanced by the rough sawn limestone facing and the use of well proportioned oxidized bronze sash. The detailing is refined but subdued.

His distinguished designs have not been achieved at the sacrifice of economy or through the use of antiquated construction techniques. He is constantly searching for better methods of construction and has successfully pioneered in the appropriate application of new techniques to varying planning situations. His elementary schools in Warwick, R. I. are outstanding examples of well-balanced coordination of plan and construction. These schools, again with a design qualities mentioned above, were the first lift slab designs in New England.

Peter has been a tireless worker for the American Institute of Architects. He has been Secretary, Vice President and President of the Rhode Island Chapter. He has been on innumerable committees in the Chapter and the Region, and in 1954, he was a member of the Institute Board of Examiners.

As Chairman of the Chapter Committee on Office Practice for many years, and Vice Chairman of the New England Regional Committee on Office Practice, he has made an outstanding contribution to the profession through his constant efforts to improve institute documents and to interpret them to the membership. Countless hours of committee work studying and restudying proper phrase-ology has not gone unnoticed and, we, in the Rhode Island Chapter, hold him in the highest esteem.

In 1948, Peter was the Rhode Island representative and spark plug of the Joint Committee which wrote the original New England "Blue Book", establishing the first uniform fee schedule in New England. He has devoted a tremendous amount of time

and effort to hold the line on the "Blue Book" fee schedules and is currently working toward a revised up-to-date version.

Peter approaches administrative problems with a determination and fairness which has given his efforts the sure authority they deserve. As a measure of the high regard in which he is held by the profession, he was selected in 1953-54 as a member of the Visiting Committee of the National Architectural Accrediting Board to help evaluate the architectural course at the Rhode Island School of Design. As a member of the staff at the school at the time, I can vouch for his thorough and impartial contribution to this important committee's analysis.

He is responsible, dedicated and able - an outstanding architect by any standards.

My acquaintance with Mr. Geddes dates from the time of his admission to the A.I.A. in 1933. He has been an active participant in the affairs of the Rhode Island Chapter, interrupted by a pariod in the Armed Services, 1943-1946, from which he retired with the rank of lieutenant colonel.

He has held a number of Chapter offices, including the presidency in 1947-48. He has been active in the affairs of the New England Regional District and the National Architectural Accrediting Board. He is a member of a state commission on the revision of fire and building laws, by appointment of the governor. He is active in the Providence Chamber of Commerce, particularly in the fields of city planning and redevelopment.

His more recent work has been in association with Albert Harkness, FAIA, including dormitories at the University of Rhode Island (1950), elementary schools in Warwick, Newport, Portsmouth and Pawtucket (1954-56), and a high school in East Greenwick (1956). Among his more modest designs are four branch banks and a Quaker Meeting House, the latter(1955) being a clever modern adaptation of the traditional plan used by the Society of Friends since the 18th century. Under construction is a 27-room elementary school in Providence. And plans are under way for a ten-story Howard Building, with the boiler room and air conditioning equipment hocated on the roof.

For his excellence in design and for services rendered to the Institute I consider Mr. Geddes worthy of Fellowship.
