Dear Mr. Gehrke:

This is in response to your inquiry through Mr. Ronald Senseman, President of our Potomac Valley Chapter.

Another chapter may be formed in your area if it is agreeable with the New Jersey Chapter.

To form a new chapter, the procedure is relatively simple:

1. Obtain the relinquishment of (or concurrent jurisdiction over) the territory involved, from the present "parent" chapter -- the New Jersey Chapter.
2. Formulate a set of by-laws consistent with Institute policy. The best and easiest means of doing this is to make up the Advisory Form of Chapter By-Laws, copy enclosed, filling in the blanks, pasting in additions, and deleting inapplicable or undesirable paragraphs.
3. Have the Application for Chapter Charter signed, in duplicate, by at least five (5) corporate members in good standing, who will qualify as charter members of the new chapter.
4. Submit the above papers to The Board of Directors for action at its next meeting. The Board will meet in May, just prior to the Centennial Celebration.
