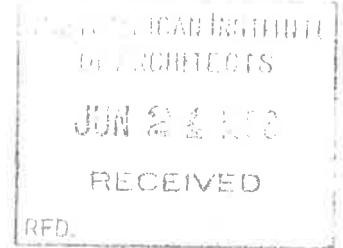

My dear Mr. Hartmann:

We have a letter from Mr. James D. Beacham of Asheville, N. C., who is Secretary and Treasurer of the North Carolina Chapter, in which he writes that the Chapter is forced to recommend the discontinuance of your membership in the Institute and the Chapter unless your indebtedness to the Chapter is cleared, or some adjustment made.

It is quite evident from Mr. Beacham's letter that the Chapter does not want to lose your affiliation, and certainly the Institute does not.

The work of the Institute and the Chapters is carried on by a comparatively small group of professional men. The cost of doing it is paid for almost exclusively from dues. It is obviously true that each member who pays his dues to the Institute, and to his Chapter, is making a real contribution to the welfare of the architectural profession.

The purpose of this letter is to call the matter to your attention and to express the hope that you will send a remittance to Mr. Beacham closing the account in full, or to such an extent as will be satisfactory to the Chapter.

We are asking Mr. Beacham to advise us when he has heard from you in order that proper notation may be made here.

We ask that you do not delay, because the Executive Committee of the Institute will meet about September 1st. Under the requirements of the Institute the Committee will be under the obligation of taking some action in your case unless adjustment with the Chapter has been made.

We earnestly hope that you will preserve your membership in the North Carolina Chapter, and in the Institute, and that you will so advise us.

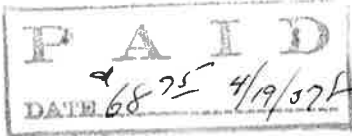





Dear Mr. Stockard:

We acknowledge letters we have received from you and Mr. Jenkins, Jr., relative to our 1957 North Carolina Chapter A.I.A. dues. These letters have not been acknowledged or replied to previously as we have had under consideration the important matter of (after these many years of membership) our resignation from the American Institute of Architects.

This letter formally acknowledges the fact that we are resigning. The letter also formally advises you we are becoming members of the A.R.A.

Our reasons for resigning may not interest you or other members of the A.I.A. or North Carolina Chapter of the A.I.A. However, of course there are definite reasons for a member of many years standing to arrive at the decision at which we have arrived. We list them below as we have to our sorrow, and our loss of projects, learned of many violations of the A.I.A. ethics by members of the North Carolina Chapter of the A.I.A. We, therefore, intend following our code which you may be assured will be honorable in every respect.

1. We were severely reprimanded when we presented flowers to a client at the opening of his building. (The client advertised the fact.)
2. We were also reprimanded when we donated anonymously space in a Horse Show brochure sponsored by a hospital client.
3. The A.I.A. policy of not permitting the membership to participate in a paid for congratulatory message to a Church or other institutional announcement is continually severely criticized by such institutions and the policy is disregarded we have experienced to our sorrow by many of our associates.

4. We understand A.I.A. local State Chapter members continually cut fees because in soliciting commissions we have learned this.
5. We understand, as recently demonstrated, an A.I.A. local State Chapter member secured a commission by providing free preliminary services including plans, elevations and costs for a brochure published to assist in the raising of construction finances.
6. We understand, as recently demonstrated, an A.I.A. local State Chapter member has over a period of years made, extensive personal gifts (as heard, radios, televisions, cars) to various County School Superintendents.
7. We understand, an A.I.A. local State Chapter member guarantees school estimates on the basis of sketches and bases his fee on his guarantee regardless of the final cost, except if the cost is lower, the fee is then based upon the low cost.
8. We understand recently an A.I.A. local State Chapter member accepted a listing A project for 6% which according to cost required a charge of 7%.
9. The Chapter dues are entirely unreasonable.
10. It is a practice (we plead guilty) of A.I.A. members accepting from manufacturers and/or their representatives expense paid trips to various sections of the U. S. to inspect the manufacture and use of materials of these manufacturers.

Many more similar ethical violations by high standing members, including Fellows, we understand have occurred.

No member is competent or has the time to police violations of ethics. This should and must be done by the Association, if it cannot be so accomplished the Association is absolutely of no use or benefit to the membership.

Gentlemen:

Copies of your separate letters of March 24 to Mr. Stockard have been forwarded to me by immediate past President W. R. James, Jr.

This letter is intended as a reply to each of you for the reason that the letter signed by Mr. C. C. Hartmann, Sr. is obviously intended to be the official letter for both of you. I personally regret to learn of your decision to resign from the Institute. It is especially regrettable that your decision is based on your knowledge or belief that your colleagues and fellow-members of the Institute are guilty of unethical conduct in their practice.

If you will not reconsider, pay up your back dues and participate actively in the affairs of the Chapter to help eradicate or improve the conditions about which you complain it becomes my unpleasant duty as current Chapter President to inform you of several facts with which you might not be entirely familiar.

1. The way has always been open to you, as it is to any member, to register a complaint with the Chapter Executive Committee against any other member who was allegedly guilty of unethical practice provided such complaint was substantiated with sufficient factual evidence. Under these conditions I assure you the Committee would have taken such action as the case indicated.

Enclosed is a copy of Article 12, Sections 1 and 2 of the By-Laws of the North Carolina Chapter which clarifies the correct procedure for such cases. This Article reflects Institute policy, not just the policy of the Chapter. I hope you will review it carefully.

2. Until your corporate membership is terminated by the Institute you are a member, or a suspended member, of the Institute and assigned by the Institute to the North Carolina Chapter.

The period of grace terminates on December 31 of the year next following the date of suspension: in your case, on December 31 of the current year.
