Gentlemen:

I sincerely support the nomination of Merritt Harrison, of Indianapolis, a member of the Indiana Society, a Chapter of the American Institute of Architects, for advancement to Fellowship.

I have known Mr. Harrison for approximately 30 years and have worked with him on many Chapter activities and served with him for several years on the Indiana Registration and Examining Board and always found him fair and most conscientious.

In 1916, Mr. Harrison, Mr. Herbert Foltz, F.A.I.A., (Deceased), Mr. Robert Daggatt, F.A.I.A., (Deceased), and Mr. Walter Scholer, A.I.A., were successful in re-vitalizing the Indiana Chapter of the American Institute of Architects. Also, in this same year, the Indiana Society of Architects was founded by Mr. Harrison, Mr. Herbert Foltz, F.A.I.A., and Mr. Donald Graham, (Deceased). Mr. Harrison served as secretary from 1917 through 1926, and President from 1926 through 1928 of the Society. Mr. Harrison worked diligently to unify the Indiana Chapter of the American Institute of Architects and the Indiana Society, but this unification was opposed by a majority of the members of the Indiana Society.

Confronting much opposition against unification, Mr. Harrison continued to work with Mr. George C. Wright, F.A.I.A., Mr. Edward Pierre, F.A.I.A., and unification was finally accomplished largely through Mr. Harrison's membership on the National Unification Committee of the Institute.

After unification, the proper title of our Chapter became the "Indiana Society of Architects, a Chapter of the American Institute of Architects" and the chapter of membership was increased approximately four times due to the vigor of the younger men taken into the Society. In 1947, Mr. Harrison was elected president of the Chapter.

Nomination of Merritt Harrison

Mr. Harrison and the writer worked diligently to promote the Indiana Architectural Registration Act, which law went into effect October 1929. In the minds of his fellow architects, this one service would justify his nomination for Fellowship.

Mr. Harrison appeared before the 1931 San Antonio Convention and with the assistance of Mr. Robert Kohn, President of the American Institute of Architects, succeeded in getting a resolution passed to re-vitalize the Building Congress of the United States and served as chairman for three years. This organization, later, became the Construction League of the United States, of which Mr. Stephen Voorhees, F.A.I.A., was made president. Later, this Organization became the Construction Division of the Department of Commerce of the U. S. Government, which has been a working tool with Congress.

Among his more prominent architectural achievements are the Coliseum, at the State Fairgrounds, several State Armories and apartments in Indianapolis.

Mr. Harrison is a graduate of Cornell University and is held in high regard by all who know him for his inherent honesty, integrity, and untiring energy.

I firmly believe that Mr. Harrison deserves advancement to "Fellowship" in the Institute for services rendered the profession and the Institute over the many past years.



FACTUAL

Gentlemen:

At the time I was nominated for Fellowship, I felt there were other architects in the state of Indiana whose names should be submitted in nomination. Outstanding in that position is my colleague, Merritt Harrison, whom I have known intimately throughout the years of my practice.

I therefore now feel it an honor that I may at this time request your consideration for his elevation to Fellowship. Mr. Harrison is being nominated for his service to the institute and for public service.

We can feel that Merritt Harrison is the father of our local Chapter, for early in this century our Chapter was so weak that it became a part of the Chicago Chapter. It was Merritt Harrison who then a young man fresh from a European trip and from working in important New York offices, felt with indignation the casual lack of importance the Institute carried in the minds of the local architects of that day.

He secured the assistance of Herbert Foltz, F.A.I.A., 'deceased, and one or two younger men, and with enthusiasm for an important project, established the Indiana Chapter of the A.I.A. in the early twenties. In the thirties, Mr. Harrison again found that the local Indiana Society of Architects was usurping the position of the Chapter and again headed the drive to bring the importance of the American Institute of Architects to the foreground. This culminated in victory, and in 1945 he was responsible for the Indiana Society of Architects and the Indiana Chapter being amalgamated, and we now have the Indiana Society of Architects, a Chapter of the A.I.A.

Mr. Harrison has been the leading fighter in this long battle that has seen the membership grow from three to seven hundred and two. The men who assisted him in this long fight to bring importance to the Institute in the local field have, for the most part, gone to

their reward and therefore cannot testify in his behalf. I therefore feel it is necessary for me to set these facts before you.

Mr. Harrison in his public service was chiefly responsible for the organization of the Indiana Building Congress which later resulted in the Construction League of Indiana and the Construction League of Indianapolis, and for the formulation of their policies and for their co-ordination with the architects. From 1932 to 1935 he was Chairman of the National Committee of Building Congresses and was later responsible for the organization of the National Construction Congresses. He is now called upon constantly to serve on committees where policy and co-ordination between the industry and the architects is of importance.

Mr. Harrison was Chairman of the Legislative Committee at the time the Indiana Architectural Act for the state was brought into being. After the Registration Act became a law, he served as a member of the Registration Board and was Chairman from 1952 to 1953, and as Chairman he instigated the legal promulgation of the Rules and Regulations of the Board.

I believe his architectural achievements are noteworthy. He was the architect for the Coliseum of the State Fairgrounds in Indianapolis. This building has the greatest spans of a two-hinged, solid, rigid-web, steel arch frames in the United States, and it is the center of civic activities.

Through a period of many years, he has done schools, churches, state armories, and country clubs wherein his clients have called him repeatedly for additional services which is evidence of his architectural integrity and ability.

In Indianapolis is the second of the Slum Clearing Projects in the United States, Lockfield Gardens. Mr. Harrison's firm with Mr. Harrison as the designer, developed this garden scheme in chevron design which has been copied in many such developments throughout the United States.

I proudly present this nomination of Mr. Merritt Harrison for elevation to Fellowship in the Institute.

I am happy that I am having the privilege of following Mr. Harrison's leadership as president of the Indiana Society of Architects.

Mr. Harrison was instrumental in starting a bulletin for the state architects. This bulletin later resulted in our new publication "The Indiana Architect".

Mr. Harrison has also been very active on the Indiana Architectural Registration Board and was instrumental in securing the present Indiana Architectural Registration Law. He served as an officer on the Board of Registration for many years.

He has also been very active in strengthening the Building Congress of the State of Indiana and the Building Congress of the United States. Through his efforts the Building Congress of the State of Indiana is still very active and the Building Congress of the United States has become the construction division of the Department of Commerce of the United States Government.
