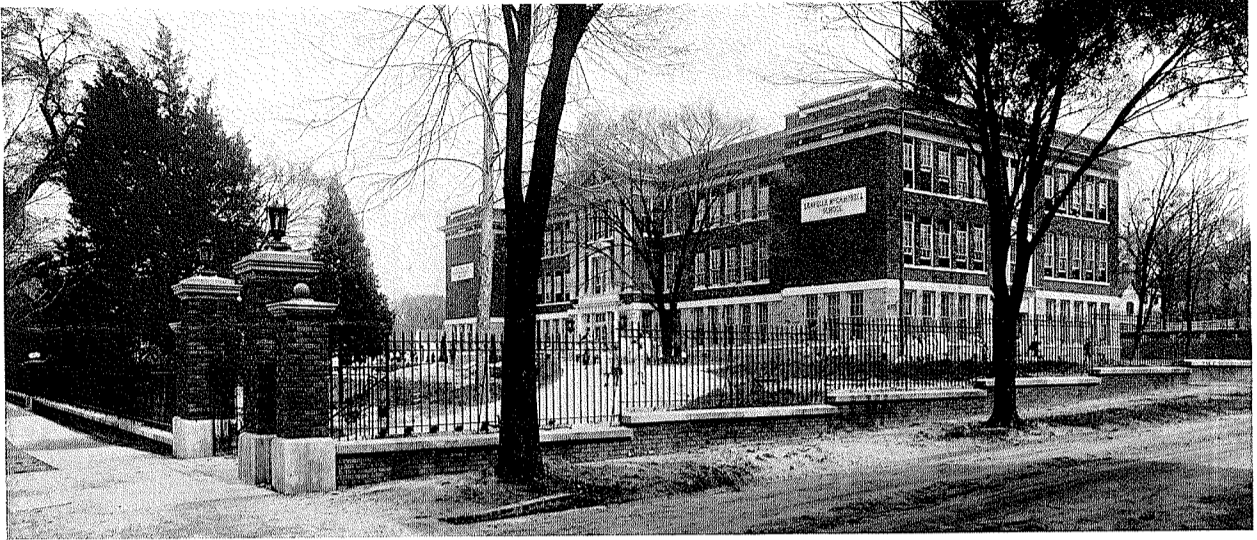

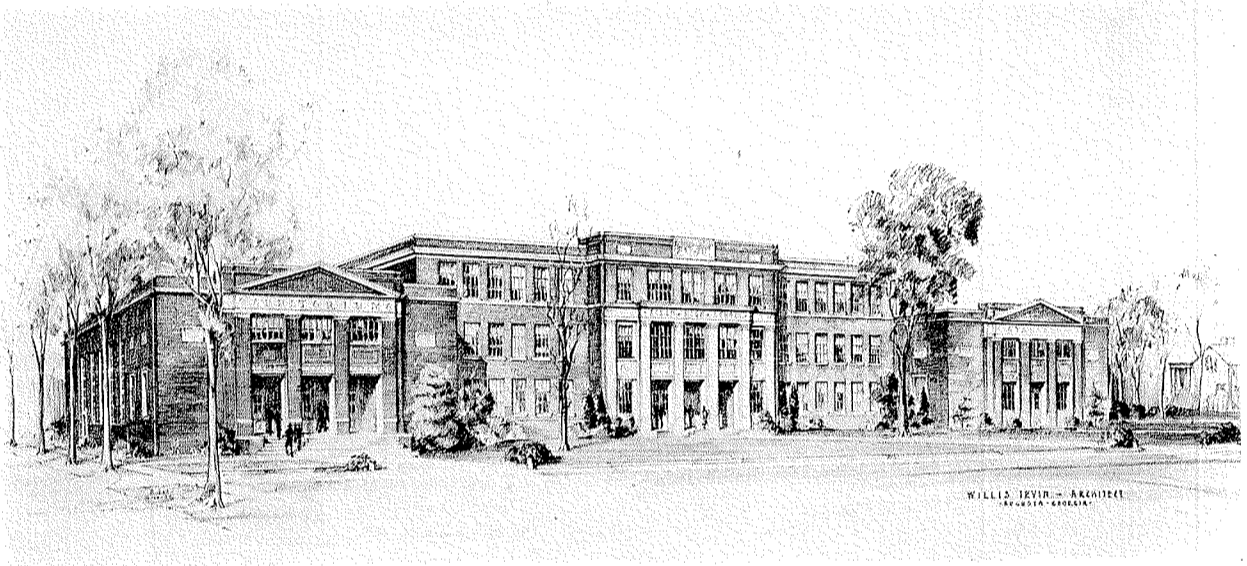

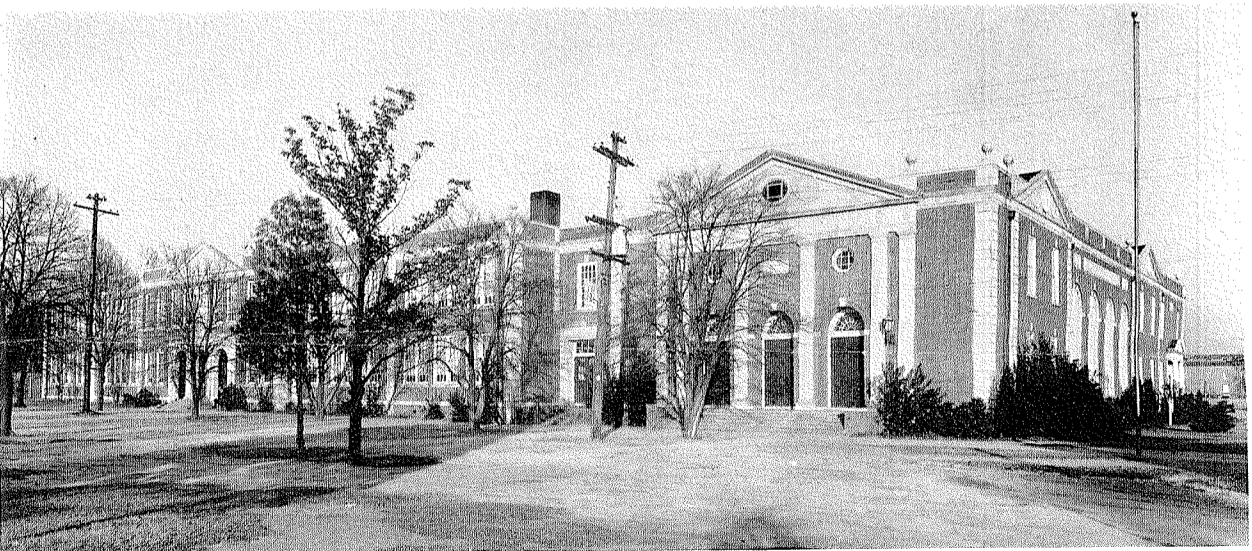


HIGH SCHOOL, GRANITEVILLE, S. C.

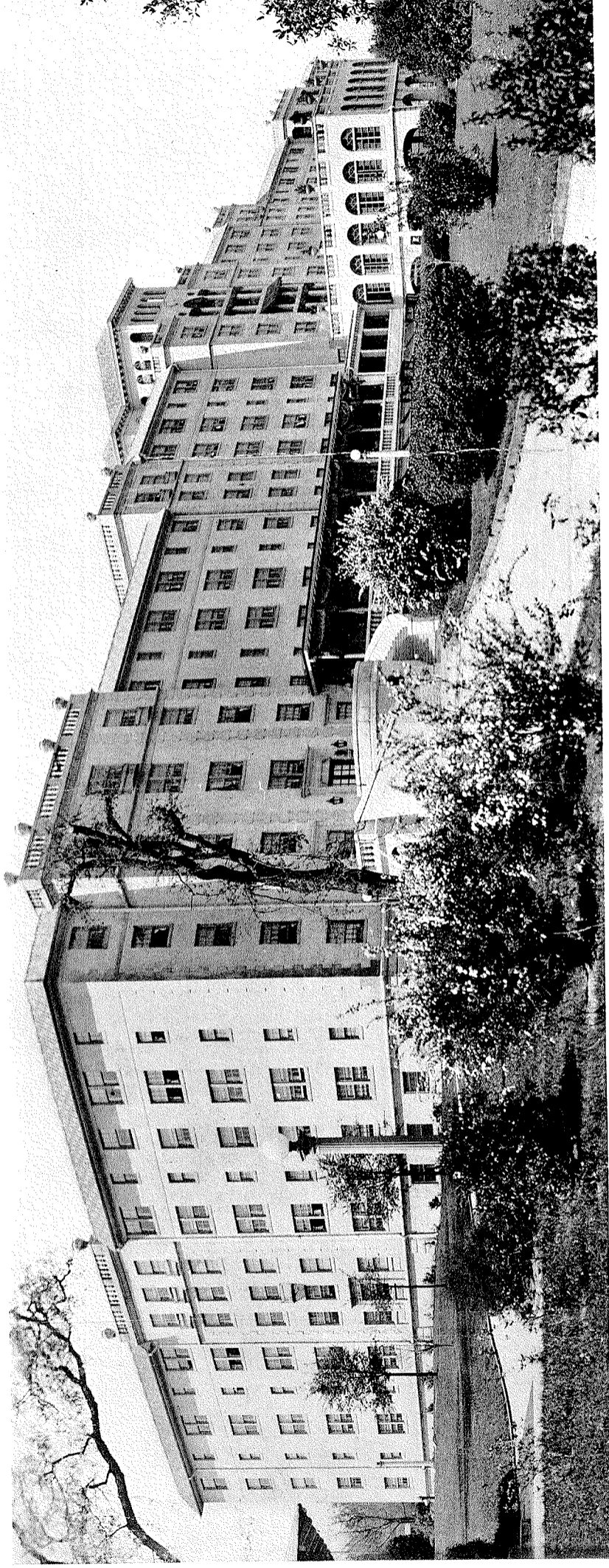


FOREST HILLS HOTEL, AUGUSTA, GA.
