A member, by virtue of his membership in The Institute, becomes a member of the chapter of The Institute within the territory of which he resides or has his place of business, as he elects, but he pays an admission fee to The Institute only. The admission fee to membership in The Institute normally is twenty-five dollars. (For 1936 this fee was reduced to five dollars.)

A member pays annual dues both to The Institute and to the chapter. The annual dues to The Institute normally are twenty-five dollars (for 1936 Institute dues were reduced to twenty dollars) and those to the chapter are fixed in its by-laws.

Normally the period between the time of filing

an application and the time it is acted on by The Board of The Institute is four months. The period will be longer if the application must be returned to the applicant for corrections or if additional exhibits of the applicant's work are required by The Board of Examiners.

If an application is denied, the amount prepaid by the applicant for annual dues and for admission fee, less five dollars for examination fee, will be returned to him.

An applicant whose application has been denied without prejudice may reapply for admission to membership a year or more after the date of The Secretary's notice to him of his non-admission.

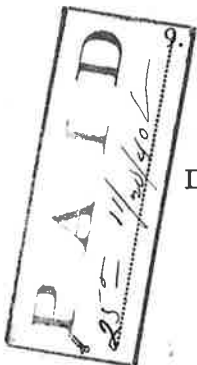



Later I had the pleasure of working under him as a draftsman on his projects and as a member of the faculty of the Department of Architecture of the Illinois Institute of Technology during the period from 1937 to 1942.

Since the war, I have had the opportunity to observe and direct the work of many young men who have studied under Mies at Illinois Institute.

In my opinion Architecture, during his generation, has produced no finer person and no finer teacher than Mies. Inspired by the clarity and integrity of his own thinking, the standard of the work in his school has reached a high level of quality that is not surpassed, and possibly not equalled, in any other architectural school today.







LONDON, Jan. 7 (Reuters)
—Queen Elizabeth has awarded the 1959 Royal Gold Medal for Architecture to Ludwig Mies van der Rohe of Chicago, the Royal Institute of British Architects announced tonight.

The award to Mr. Mies van der Rohe, the seventh American to win it, was made on the recommendation of the institute.

The 72-year-old German-born winner is director of the School of Architecture at the Illinois Institute of Technology. He left Nazi Germany for the United States in 1938 and became an American citizen six years later.

He was co-designer of New York's recently completed Seagram building, which "many critics regard as his masterpiece," the institute recalled.

The Royal Gold Medal was started by Queen Victoria in 1848.

Dear Mr Allen,

It is hard to believe that Mies van der Rohe is dead, so omnipresent has been his work and personality. Those who were fortunate enough to see his projects for skyscrapers at the Novembergruppe exhibitions in Berlin in 1920 and 1921 must have perceived at once that here a new style had been born; but no one could then have predicted - what is now a fact of history - how profound was to be Mies' impact both on American architecture and on American architectural education.

When he came to America in 1937 he discovered an immensely sympathetic environment. In replying to the award of your Institute's Gold Medal of Honor he expressed his deep gratitude for the opportunity to teach and to work in America, and added, "The teaching forced me to clarify my architectural ideas. The work made it possible to test their validity. Teaching and working have convinced me, above all, of the need for clarity in thought and action." Here, and in the strikingly apt words from St Augustine which your Institute chose to quote in the accompanying citation - "Beauty is the splendour of truth" - is the key to his life's work.

On behalf of the Council and Members of the Royal Institute of British Architects I offer to the American Institute of Architects our profound condolences on the loss of one who has enriched all our lives.
