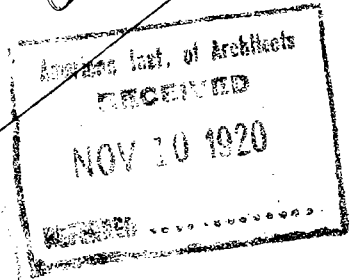

At a meeting of this Chapter held in January, at Columbia, it was resolved that as Mr. J. C. Johnson of Columbia, S. Dear Mr. Waid:

At the Board meeting the case of Mr. J. C. Johnson of the South Carolina Chapter was referred to you with power.

As relevant I enclose original letter of March 3 from Mr. Walker, the Secretary of the Chapter, and in a letter of May 23 Mr. Walker says he would be glad to know concerning the action of the Board on this case.

Mr. Johnson is indebted to the Institute for dues for 1920 only. Two courses of action suggest themselves, one a letter from the Treasurer to Mr. Johnson giving him opportunity to square himself with his Chapter, and the other to discontinue his membership on the strength of Mr. Walker's letter of March 3. Will you not advise Mr. Walker of your decision in this matter. In acknowledging his recent letter I stated that you would be glad to have any recommendations that he might care to make, although it is possible that he has fully governed the case from the Chapter's viewpoint from his letter of March 3.

dropped from the roll of the Institute.


In regard to this matter, I wish to say that I

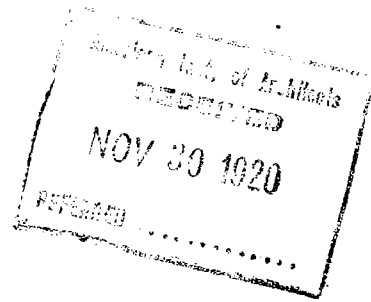

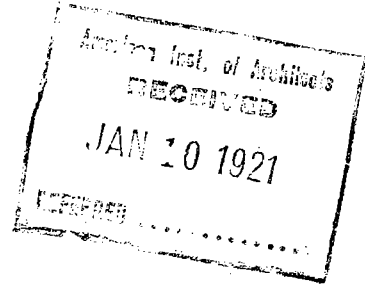
