I wish to acknowledge receipt of your letter of March 19th and for enclosing a copy of the New York Chapter's letter to you of March 3rd.

The question that you have raised relative to maintaining membership in the National Institute alone and not a chapter membership, has come up a number of times and has been thoroughly discussed and The Institute's By-Laws and Policy remain the same. In other words, membership in the national body does entail membership through assignment in the appropriate local chapter and consequently the dues of the local chapter have to be met in order to maintain good standing in The Institute.

With respect to your last paragraph, I am inclined to be a bit more optimistic as it looks to me as if the situation is clearing up and that the profession and the construction industry will be normally and busily engaged in the relatively near future.



Dear Mr. Ferriss:

About a year ago, I notified the Chapter, as well as the Octagon, that owing to the fact I left the City and am semi-retired at the above address, I requested the possibility of maintaining my national membership and giving up my Chapter membership, as I have not been to a Chapter meeting in almost two years. Further, living up here, it was very unlikely that I would attend any further meetings in New York.

I was duly informed that such an arrangement was impossible and I, therefore, resigned and have a notice of resignation from the Octagon stating that my resignation from the Institute as of June 16, 1952 is effective and in the Chapter as of June 30, 1952.

Certain conditions have arisen, that I have a ssociated with Keally and Petterson, and in view of same, have decided to renew my membership and realizing that I had to join a Chapter, decided on the Eastern Chapter located in Albany, only 35 miles away. I so notified the Institute on January 16, and they in turn contacted the New York Chapter, apparently thinking that I was going to renew my status there.

When I received a billfrom the Chapter dated March 4, calling for dues from October 1 to Septêmber 30, I returned it and advised them that I was going to join the Chapter in Albany.

Assuming that this was in order, I sent acheck for \$50.00 to the Octagon, and under date of April 13, have word from Clair W. Ditchy, Secretary, that notice of request for transfer has been issued but there seems to be a question in the New York Chapter that I owe some dues from October 1 to March 31. This is rather hard for me to understand when I was supposedly resigned as of June 30 so, to my mind this has become terrifically involved and I trust you will be able to give me a clear bill of health.

I am sure you will appreciate that as far as I am concernded, I have not been a member of the New York Chapter since June 30, although dues may have been paid up for the year.

Dear Mr. Alexander:

We have reviewed the correspondence and problems which seem to have arisen in the case of your return to membership in The Institute and the New York Chapter efter resigning in the middle of last year. We trust that this letter will serve to fully explain what has transpired and give you a choice of actions.

When your application for readmission to membership was received here under date of January 16, it was noted that in order to apply for readmission, it would be necessary for you to pay the \$10.00 readmission fee plus first year's dues in advance in the amount of \$50.00, making a total of \$60.00. The suggestion was made and sent to you that a better and much quicker procedure would be to asneel your previous resignation. This would save you the \$10.00 readmission fee and would enable us to place your name on the rolls as a member promptly.

Under the usual procedure of readmission, it is required that the applicant's name be circulated to all chapters (along with all other applicants for membership and readmission to membership) for a period of thirty days. After that, the application is considered by The Board of Examiners at its next meeting (perhaps a munth away). It is then submitted to The Secretary of The Institute for final approval on behalf of The Board of Directors. This process quite obviously takes a few months.

When our suggestion was made, we had not considered any such problem as your dues to the New York Chapter, which naturally fell due when your membership was reinstated as of the date of your resignation, rather than as of the date of your application to become admitted to The Institute again.

In view of the fact that the Chapter dues are \$17.50, but that you have been saved the \$10.00 readmission fee, it is apparent that there has been a net loss to you in the amount of \$7.50 under the present arrangement.

If you prefer, we shall reprocess your application for readmission in the normal manner, which would necessitate a request that you pay the \$10.00 readmission fee. This would enable you to save payment of New York Chapter dues, but would entail a period of waiting for a few months for the processing of your application.

Dear Mr. Rankin:

Your favor of May 5 herewith acknowledged and I am sorry to advise it leaves me quite cold as I must call your attention to the following facts.

I resigned by letter to the New York Chapter on April 25, 1952 and paid my dues to September 30, 1952.

I resigned to the Institute by letter June 6 per instructions of the Chapter.

You sent me an official notice on August 13, 1952 that you had accepted my resignation for both Institute and Chapter, as of June 6.

My letter to the Institute on January 16, 1953 written during a business trip to the West Indies, requested you to send me the proper papers for my re-admission to the Institute.

On March 4 you addressed me in complete error, as quote, "you wish to resume your corporate membership in the Institute and the New York Chapter." Please refer back to my letter of January 16 and you will note I did not make a request to join the New York Chapter.

I addressed you on March 14 advising you of my intentions, and reasons for, desiring to join the Albany Chapter and sent you my check for \$50. yearly dues in the Institute.

Then a month later on April 13, I received a letter from Clair Ditchy that I should pay the New York Chapter an amount of \$17.50.

My conclusions are:-

1. I did not ask for readmittance to the New York

Chapter and you were in error in assuming such status.

- 2. I resigned per your own notice as of June 6, and therefore had a credit as I paid to September 30.
- 3. You had no right to accept my check for \$50. yearly dues in the Institute as my letter accompanying my check distinctly stated I was going to join the Albany Chapter.
- 4. In view of the bove, I refuse to pay \$17.50 to the New York Chapter or \$10. to you and \$7.50 to the New York Chapter, as you suggest.
- 5. If your Executive Board do not agree with the above, please return my \$50. check and also advise the Albany Chapter to return my \$10. yearly Chapter dues and we will call the matter closed with no hard feelings.

This is apparently a misunderstanding between us and I harbor no ill feeling, but as a matter of principal, in view of the above, I can't reason why I should give the New York Chapter anything.


