



Furthermore, in the dimn recesses of the past, I was consecutively Secretary of the Grand Rapids Chapter, Treasurer of the Grand Rapids Chapter, President of the Western Michigan Chapter and President of the Michigan Society of Architects. I felt that I was entitled to devote my spare time to composing my autobiography which is to be entitled "How to Become a Mean Old Man Like Me and Why Should Anyone Want To".



Roger Allen, FAIA

Roger Allen, FAIA, was born in June, 1892 and died in 1971. Allen had written a daily column, "Fired at Random" for the Grand Rapids Press since the late 1930's and was a frequent contributor to humor magazines. His firm's work was principally in educational and institutional buildings. He served in World War I as a U.S. Naval Officer.

In 1954 Allen was the president of the Michigan Society of Architects, and had also served as vice president and a director of the MSA. He was also a past president, secre-

tary and director of the Grand Valley Chapter of the AIA, Allen was awarded the MSA Gold Medal and became a fellow of the AIA in 1954.

Both Central Michigan University and Ferris Institute in Michigan awarded honorary degrees to Allen for his part in helping to design most of the buildings at these two universities. In December of 1970, Allen became an Emeritus member of the AIA while a member of the Grand Valley Chapter. Allen died after a long illness.
