A receipt to cover the preliminary fee of \$5.00 is enclosed.

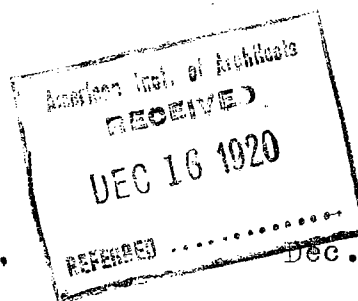
