

Edgardo Contini is the Godfather of urban design and planning in Los Angeles, the conscience of the profession and the center of the discussion on planning for its growth. He has done this as a partner in the firm of Victor Gruen Associates and as an individual advocate in the community at large.

After World War II, when few colleagues were concerned with urban design, Edgardo formed the Regional Plan Association of Los Angeles. It gave young architects and urban planners a better understanding of the world they were creating in Los Angeles. As a member of the executive council of the Goals Program, he crucially impacted the future of Los Angeles.

Professional accomplishments include planning for the Pacific Design Center, the infrastructure planning for the Bunker Hill California Plaza design, and the ecologically sensitive plan for the Glenwood Canyon Freeway. His ideas and his idealism are recorded in literally dozens of publications and speeches.

### CAREER PROFILE

Contini fled Mussolini's Italy for the United States in 1939 and spent a short while in New York where he pursued courses in urban design and planning at the progressive New School for Social Research. He next worked for Albert Kahn in Detroit where his work included the engineering of many large industrial factories and military manufacturing plants. He was able to contribute innovative and highly efficient solutions to long-span construction during the war when materials were in short supply.

From the office of Albert Kahn, Contini was drafted into the United States Army and, through a bureaucratic fluke, landed in Europe with the Corps of Engineers. As "an enemy alien in the North American army" Contini performed Merlinesque feats on a variety of military installations and ultimately won the Legion of Merit award for his reassembling of an industrial laundry (without plans) in North Africa.

When the war was over Contini settled in Los Angeles where he worked with John Lautner on a series of experimental houses which served as prototypes for post-war housing needs.

Two years later, when Contini was asked to become one of three designers (with architects A. Quincy Jones and Whitney R. Smith) of the 800 acre Mutual Housing cooperative, he took the opportunity to start his own practice. Mutual Housing (aka Crestwood Hills) was one of a few cooperative housing developments established to respond to the post-war housing shortage. This development was the first racially integrated project in southern California.

The architects also blazed political trails in challenging FHA rules for low-cost construction techniques. Contini was primarily responsible for the overall planning and site design of the 500 unit development. He took the opportunity to preserve essential features of the rugged hillside and to create communal open space in the flat areas of the canyon at a time when other developers were flattening hillsides to create ordinary buildable pads.

Besides Mutual Housing, Contini became the engineer for Charles Eames' innovative Case Study House as well as that of Raphael Soriano.

Contini took on a propitious client in 1949 when he assisted Victor Gruen in resolving a structural issue with underground parking. It was at that time that the Hudson Company became aware of Gruen's seminal article on the shopping center as a new building type. Hudson commissioned Gruen to identify likely sites for shopping centers around Minneapolis given the post-war trend for suburban development. The sites were purchased and the team designed Northland, the country's first shopping center.

## CAREER PROFILE

In 1951 the collaborative team of Gruen, Contini, Rudy Baumfeld and Karl Van Leuven formed the original partnership of Victor Gruen Associates, the firm which would dominate the field of urban planning world-wide for over two decades. The projects Contini spearheaded during his twenty-eight years as partner of Victor Gruen Associates include planning the downtown renewal of Fort Worth, Texas; Fresno, California; Rochester, New York; and the planning of new cities in Litchfield Park, Arizona; Laguna Niguel, California, as well as master plans for Tehran and Honolulu. Contini was Partner in Charge of a number of projects, working with Cesar Pelli who later joined the firm as Partner in Charge of Design, notably Fox Hills Mall and The Pacific Design Center in Los Angeles, and Queen's Center in New York City.

In 1979, at the request of Dean Harvey Perloff, Contini assumed the presidency of Urban Innovations Group, the practicing arm of the UCLA Graduate School of Architecture and Urban Planning. During his tenure there he established the credibility of the student staffed firm on highly visible, major design efforts such as Charles Moore's Beverly Hills Civic Center and the Los Angeles Bunker Hill design competition with Barton Myers, Cesar Pelli, Hugh Hardy, Frank Gehry and others. Contini retired from UIG in 1984 to begin a private consulting practice, leaving UIG quite secure.

In his present role as a consultant, Contini is what he calls the "mid-wife" of collaborative efforts with architects such as Skidmore, Owings and Merrill, Charles Moore, Barton Myers and Frank Gehry. In this role he does "not conceive a project or give birth but he makes it happen". To these collaborations he lends humor, expertise and a lifetime of wisdom.

A newspaper columnist reporting on Contini's presentation to a UCLA conference on urban renewal wrote, "He has the accent of an upgraded Chef Milani...sparkles with exquisite back-hand humor...displays prodigious command of planning facts and figures...and knows how to talk."

## URBAN DESIGN ACHIEVEMENTS

In 1946, Edgardo Contini was one of three designers to plan, design and construct the 800 acre, Crestwood Hills cooperative housing development in response to post World War II housing shortages. He was responsible for the overall plan including saving the rugged hillsides that still remain in urban West Los Angeles. This was the first racially integrated housing development in the United States.

In 1949, Contini participated in the conceptualization and design of the country's first enclosed multi-level shopping center, Southdale in Minneapolis. Designed as a "town" center it became a model for shopping, eating, entertainment and meeting in all weather conditions.

Contini participated in the first plan for the closure of downtown Fort Worth, Texas to vehicular traffic and the design of the renewal project and transportation plan. This design became a "textbook" for city urban planning in architecture schools throughout the United States.

Contini led the design and planning team for the country's first downtown pedestrian mall in Fresno, California. He was responsible for full implementation of the mall itself including the creation of citizen, private industry and governmental partnerships. He created the prototype for several similar projects nationwide.

In the early 1960s, Contini's design formulated a policy statement for a national policy on the creation of new independent cities.

Contini was a lead participant in the creation of plans for several proposed new cities for both public and private sponsors including the radial/nodal concept for integrating transportation systems and land-uses.

While at the Gruen office, Contini served as Partner in Charge and Urban Designer for the Glenwood Canyon Roadway, an environmentally sensitive and aesthetically pleasing highway project. Later, as an independent Consultant to the DMJM architectural firm, he participated on the same project, always inspiring his teammates with his idealism and high spirits while solving problems of access, parking, energy and environmental control with his creative yet technical mind and philosophy:

"To conceive the framework; to care for the unglamorous innards; to respond to the vision of others; to create opportunities out of problems; to resolve complexities .... what better challenge, what greater pleasure?"







A diagonal axis passes the City Hall and groups three elliptical courtyards. The courtyards are bounded first by rows of palms and then by arcades that front the buildings and support a series of ramped walkways designed to make it easy for all, including the less mobile, to pass from one building to another protected from the elements. The diagonal sequence through the courtyards also suggests a natural progression of movement from the downtown of Beverly Hills through a large open gateway into the gardens. The 450-car, seven-level parking structure was completed in 1986; the Fire department headquarters opened early in 1987, Currently under construction are the landscaped courtyards, the library renovation, and the Police Facility, which will house all department administration functions, the jail holding facility, and the City's emergency operations and communications center. Completion is scheduled for late fall 1989.




BEVERLY HILLS CIVIC CENTER SITE PLAN

Preparation of the Comprehensive Master Plan for the Capital City of Tehran, Iran was awarded to Gruen Associates in 1966. It was the largest planning assignment awarded to private consultants at that time. Edgardo Contini, the partner in charge of the project for Gruen Associates, directed development of a master plan that had as its central theme making Tehran a better place in which its present and future population could live, work and play. He guided the efforts of a 40 person planning office, established in Tehran. The Concept of the General Plan for Tehran represented a series of large urban communities separated by open space preserves which follow the natural valleys originating in the Alborz Mountains to the north of the city. These major communities were aligned in a linear pattern and were served by alternating systems of rapid transit and highway network. Each community had a major urban core located along the rapid transit system. The community cores included such uses as government offices, private businesses and major health and educational uses designed to relieve the congestion created by locating all major urban land uses in the existing downtown.



# Edgardo Contini; Architect, Urban Planner

Edgardo Contini, an architect, engineer and urban designer described by his colleagues as the conscience of the planning profession in Los Angeles, died Saturday of complications of cancer at his home in West Los Angeles. He was 76.

Born in Ferrara, Italy, and trained at the University of Rome, Contini was first drafted into the Italian army but then was ousted under Benito Mussolini's "Racial Manifesto." Contini was a member of a prominent Jewish-Italian fam-

Contini emigrated to the United States in 1939 and served in the U.S. Army Corps of Engineers in Europe during World War II. After the war he settled in Los Angeles and in 1951 became a founding partner of the firm of Gruen Associates. At Gruen, Contini was responsible for planning many major Los Angeles projects, including the Pacific Design Center and the Fox-Hills Mall.

In 1979 Contini was appointed president of the Urban Innovations Group, the practicing arm of the UCLA Graduate School of Architecture and Urban Planning. At UIG, Contini participated in the Grand Avenue proposal for the development of California Plaza on Bunker Hill and in the planning of the expansion of the Beverly Hills Civic Center with architect Charles Moore.

Contini lectured at UCLA, the USC School of Architecture, the

Southern California Institute of Architecture and the Art Center College of Design. He was active in the Urban Design Advisory Coalition and contributed articles on urban design and planning to many professional journals.

He also received numerous awards, including the Harlan Bartholomew Award and the prestigious Fellow of the American Institute of Architects, bestowed earlier this year.

In sponsoring Contini for that fellowship, architect Frank Gehry wrote: "Edgardo is a rare combination: a creative design talent who also possesses a technical, practical sensibility coupled with a gift for making people understand."

Contini described his design philosophy as a desire "to create opportunities out of problems... what better challenge, what greater pleasure?"

He was a lifelong advocate of renewing and recycling urban buildings rather than continuing to erect new ones.

As long ago as 1972 he wrote that "if we should place the emphasis on recycling, no further withdrawal from our resources of open land would be required . . . and by moving on to something new, [we will] escape the responsibility for the urban litter we leave behind."

On his retirement from UIG in 1984, friends and colleagues established the Edgardo Contini Lecture at the UCLA School of Architecture and Urban Planning in his honor.

Contini is survived by his wife, Phyllis, three children from a former marriage, John, Nora and Barbara, and a grandson.
