Dear Mr. Delehanty:

This will acknowledge your remittance of \$ 20.00, which has been credited on account of your dues in default.

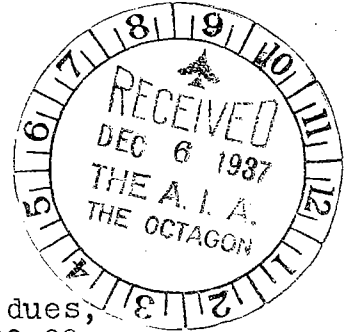
