But later, it occurred to me that the books would just stay on the shelves and be of no use to any one. Then I met Mr. Cunningham who told me that the Institute had loaned the books left to it to the Washington University, so I thought that it would be a good idea, as the University of Florida had just established an architectural department, to lend the books to the U. of F. My family lived there at one time and I was born in Florida, so I am naturally more interested in having my books at the U. of F. than at Washington University.

The department at the U. of F. is in charge of Mr. Rudolph Weaver, an able man, who is doing fine work among the men. The exhibit of the student work was most creditable considering that the course had only been established since September.

Please take the matter up with the Board and let me know how it feel about the matter.

Dear Sir-

I am sorry to report a case of unprofessional conduct by two of my confreres, here. The firm of Mark and Sheftall, Clark Building, Jacksonville, Florida. Mr. Sheftall is now acting as Secretary of the Florida Chapter.

Sometime ago, I was appointed by the Board of Public Instruction to build a school for the Board. I have a letter signed by the Board authorizing me to do so.

I made the working drawings after the Board had instructed me to do so. The cost exceed the amount that the Board thought it could spend on that building. I had obtained an estimate on the sketches which was about \$75,000. The bids exceed the estimate by \$20,000. So I felt more or less responsible and offered to remake the drawings at my own expense. The Board was to let me know the following Monday. This was the Saturday before, about eleven o'clock.

Monday, I received an unsigned letter from the Board saying that the Board appreciated my interest but the building was too costly. But no reference to my proposition or dismissal. I never received any letter in regard to my proposition and only after phoning the Chairman several days later did I know that they had given Mark & Sheftall orders to get into shape for bids plans that they had prepared several years before and which had not been erected on account of lack of funds.

As soon as I found this out, I employed an attorney and went to see Mark and Sheftall. I told Mr. Mark who saw me that I considered their action in accepting the commission as unprofessional and one that I would not have been guilty of toward them. Mr. Mark said the Board told him that they had not settled with me but would. Since I have heard nothing either from the Board or Mark and Sheftall. I saw in the paper several days ago that they had advertised for bids on the school. So they disregarded me entirely in the matter and went ahead.

My attorney also went to see them and tried to make them see our side of the question and how much it meant to me to erect that school, as it was the first public work that I have had since moving to Florida.

The settlement, as the Board seems to think, with me, and the last money received from the Board, was the payment at 4% for the working drawings on the basis of the amount that the Board was willing to put into the building. No other settlement has been made as I do not consider myself dismissed by the Board as it never broached the subject to me. This was before bids were received.

This is not the first time that this firm has been guilty of unprofessional conduct since they have been in the Institute, but it is the first time that I have been able to get the positive evidence against them. They go into unauthorized competitions and talked about other architects in such a way that they have lost the work.

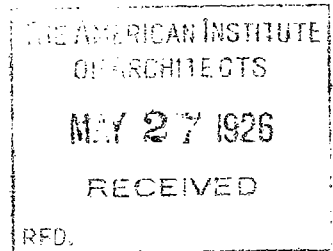


I represent a Miss H. C. Dozier, an architect of this city who is a member of The American Institute of Architects. Miss Dozier placed in my hands some time ago a case for the recovery of certain monies against the Board of Public Instruction herein the county of Duval, State of Florida, and the facts appertaining to her claim are as follows:

The Board of Public Instruction by a resolution agreed to let Miss Dozier draw plans for the construction of a certain school building. Miss Dozier did not have any knowledge of this resolution until same appeared in a newspaper. Miss Dozier drew several sets of school plans for the Board of Public Instruction, at the time of presenting her second sketch the board stated that they could only expend \$60,000.00 in the construction of a certain building and she stated to the Board that it would cost considerable more than \$60,000.00 to build a school building of the size etc that the Board of Public Instruction wanted. Miss Dozier thereupon presented her plans and bids on her plans were presented and as her plans called for an expenditure of something like \$90,000.00 the Board rejected her plans but Board of Public Instruction did not by proper resolutions discharge Miss Dozier but paid Miss Dozier \$1800.00 and called in another firm of

architects. Miss Dozier, therefore wants to know whether or not you have any citation or decision of any Court that would show that she has the right to re-cover by reason of the foregoing facts. I have gone carefully into the law respecting this matter and given Miss Dozier my opinion and advice as to the institution of a suit, however, she insists upon my writing you for the above information.

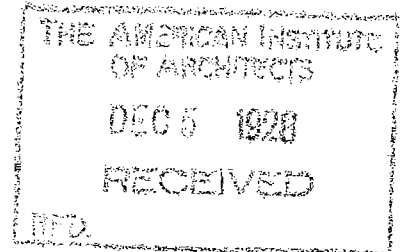

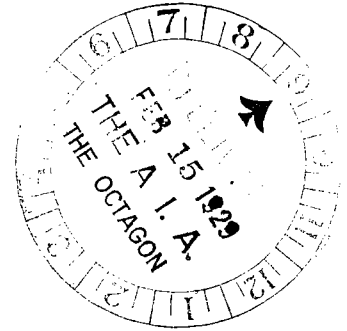

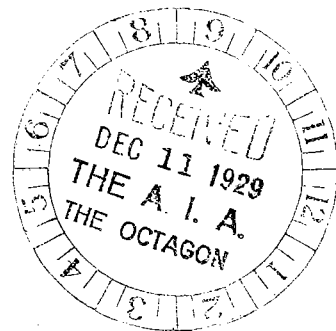
