#### PROFESSIONAL CAREER

BIRGE MALCOLM CLARK

Born April 16, 1893

A. B. Stanford 1914; Bachelor of Architecture, Columbia 1917.

Served two years in Air Service World War I, Captain, Balloon Company commander, received Silver Star citation.

After war, while associated with father, A. B. Clark, designed residence for Mr. and Mrs. Herbert Hoever. Opened own office in Palo Alto in 1922. First partner, younger brother (now deceased) 1929 until 1944; present partner, Walter Stronquist since 1945.

Practice has been very general and Palo Alto has many examples of his work; residences, stores, garages, office buildings, banks, newspaper plant, public and private schools.

During World War II was consulting architect on Kaiser's Fontana steel plant and designed various specific buildings such as the administration building; did similar work for the Kaiser magnesium plant, and in Oakland, the Permanente Hospital. In San Francisco, the Stanford Medical School Research Laboratory.

His office has done and is doing schools within a twenty mile radius of Palo Alto, at San Jose, Campbell, Cupertino, Mountain View, Centerville and Decoto; also, a great number of large and small residences; among the larger that for Charles and Kathleen Norris, residences of Mrs. Louis Stern and daughter Buth Stern, Harold Hamilton.

In public work, other than schools, designed the Palo Alto Post Office for the Federal Government; the Palo Alto Fire and Police Station, Palo Alto Community Center, the Palo Alto Red Cross Building, and, at present, the first unit of the Santa Clara County Government Center.\*

In the field of public service and relations, he has served both as Director and President of the Palo Alto Chamber of Commerce; a Director and President of the Palo Alto Mutual Building & Loan Since 1940; Chairman of the Survey Section of the Disaster Committee of the Palo Alto and Stanford Red Cross, a Charter and 25-year member of the Palo Alto Kiwanis Club, Boy Scout Committeeman and various civic committees; served on mayor's committee studying signs, and as a result of a movement initiated by him, Palo Alto is one of the few cities in the state in which no signs of any sort are allowed to extend out over the sidewalk, but must be limited to one foot projection beyond the building. At present time is lecturer for second year in newly formed Architectural School at Stanford University.

Professional relations: A 25 year Corporate Member of the Institute; served as Director of the Northern California Chapter and on various committees. Delegate to national convention. While chairman of the Membership Committee

devoted regular time to calling on non-member architects, some of whom had been estranged from the Institute by ancient feuds, and was instrumental in bringing several back to the Chapter. Participated in the organization of the Coast Valleys Chapter and served as President in 1949 when it was a branch chapter of the Northern California Chapter. Has been active on various committees and currently chairman of Relations with Construction Industry Committee. Served on the Code Changes Committee of the Uniform Building Code and actively participated in developing the present school portions of the Code. Currently has met with the same committee and the State Fire Marshal in formulating Title 19 of the State Code regulating fire safety in public buildings. In the case of Palo Alto, has at several times been appointed by the Board of Public Works to work with the Building Inspector in rewriting certain chapters of the Palo Alto version of the Uniform Code. Is well known to, and has worked with the Building Inspectors of Palo Alto, San Jose and Counties of Santa Clara and San Mateo, and has been instrumental in bringing about a better understanding between architects and building inspectors and assisting in improving the present building codes. He was very active in representing the Palo Alto architects in reviewing for the Planning Commission architectural sections of Palo Alto's present master plan when it was before the Council for review. The work of the architecty was especially appreciated by members of the Planning Commission and his efforts led to definite improvements in various sections relating to architecture in the master plan.

\* This last also involved the development of presentation of needs and the master plan for this inter-governmental center which would comprise offices of the City of San Jose, the County of Santa Clara, and state and federal governments.

#### PROFESSIONAL CAREER

BIRGE MALCOLM CLARK

Born April 16, 1893

A. B. Stanford 1914; Backelor of Architecture, Columbia 1917.

Served two years in Air Service World War I, Captain, Balloon Company commander, received Silver Star citation.

After war, while associated with father, A. B. Clark, designed residence for Mr. and Mrs. Herbert Hoover. Opened own office in Palo Alto in 1922. First partner, younger brother (now deceased) 1929 until 1944; present partner, Walter Stronguist since 1945.

Practice has been very general and Palo Alto has many examples of his work; residences, stores, garages, office buildings, banks, newspaper plant, public and private schools.

During World War II was consulting architect on Kalser's Fontana steel plant and designed various specific buildings such as the administration building; did similar work for the Kalser magnesium plant, and in Oakland, the Permanente Hospital. In San Francisco, the Stanford Medical School Research Laboratory.

His office has done and is doing schools within a twenty mile radius of Palo Alto, at San Jose, Campbell, Cupertino, Mountain View, Centerville and Decoto; also, a great number of large and small residences; among the larger that for Charles and Kathleen Norris, residences of Mrs. Louis Stern and daughter Ruth Stern, Marold Hamilton.

In public work, other than schools, designed the Palo Alto Post Office for the Federal Government; the Palo Alto Fire and Police Station, Palo Alto Community Center, the Palo Alto Red Cross Building, and, at present, the first unit of the Santa Clara County Government Center,"

In the field of public service and relations, he has served both as Director and President and President of the Palo Alto Chamber of Commerce; a Director and President of the Palo Alto Mutual Euilding & Loan since 1940; Chairman of the Survey Section of the Disaster Committee of the Palo Alto and Stanford Red Cross, a Charter and 25-year member of the Palo Alto Kiwanis Club, Boy Scout Committeeman and various civic committees; served on mayor's committee studying signs, and as a result of a movement initiated by him; Palo Alto is one of the few cities in the state in which no signs of any sort are allowed to extend out over the sidewalk, but must be limited to one foot projection beyond the building. At present time is lecturer for second year in newly formed Architectural School at Stanford University.

Professional relations: a 25 year Corporate Member of the Institute; served as Director of the Northern California Chapter and on various committees.

Professional Carser Birge M. Clark - 2

Delegate to national conventions. While chairman of the Membership Committee devoted regular time to calling on non-member exchitects, some of whom had been estranged from the Institute by encient feuds, and was instrumental in bringing several back to the Chapter. Participated in the organization of the Coast Valleys Chapter and served as President in 1949 when it was a branch chapter of the Northern California Chapter. Has been active on various committees and currently chairman of Relations with Construction Industry Committee. Served on the Code Changes Committee of the Uniform Building Code and actively participated in devoloping the present school portions of the Code. Currently has met with the same committee and the State Fire Marshal in formulating Title 19 of the State Code regulating fire safety in public buildings. In the case of Palo alto, has at several times been appointed by the Board of Public Works to work with the Building Inspector in rewriting certain chapters of the Palo Alto version of the Uniform Code. Is well known to, and has worked with the Building Inspectors of Palo Alto, San Jose and Counties of Santa Clara and San Mateo, and has been instrumental in bringing about a better understanding between erchitect and building inspectors and assisting in improving the present building codes.

He was very active in representing the Palo Alto architects in reviewing for the Planning Commission architectural sections of Palo Alto's present master plan when it was before the Council for review. The work of the architects was especially appreciated by members of the Planning Commission and his efforts led to definite improvements in various sections relating to architecture in the master plan.

\*This last also involved the development of presentation of needs and the master plan for this inter-governmental center which would comprise offices of the City of San Jose, the County of Santa Clara, and state and federal governments.
