As a member of the Executive Committee of the Rhode Island Chapter, American Institute of Architects, I had the pleasure of participating in the nomination for Fellowship in the Institute of Philip Douglas Creer.

I have known Phil Creer as adviser, committeeman, fellow teacher, architect and friend for twenty years. During that time, my respect and admiration for him as an educator, architect and man has grown continuously.

When I was a confused college student during the depression, his sound and frank counsel was influential in my decision to study architecture. Friendly, helpful advice to me and other youngsters is typical of Phil's dedication to the profession.

'Phil Creer was head of the Division of Architecture at the Rhode Island School of Design in Providence for over twenty years. It was my privilege, as a design instructor there for a period of six years, to work under his guidance and leadership. Through close association, I had the opportunity to witness, at first hand, his sure guidance of the division. He constantly strove to improve the school's standards of education in architecture and was successful in gradually raising the architectural course from what was essentially a two-year trade school course for future draftsmen to a full five-year college level course accredited by the National Architectural Accrediting Board. This achievement gains more significance in the light of difficult adminis-

trative obstacles he faced. Dedication to education, to the needs of the profession and his pupils has steadily increased his influence in the field of architectural educa tion to its present high level.

His Institute activities have been many and varied. the years, he has continually accepted the challenge to help out. He has been Secretary, Vice President and President of the Rhode Island Chapter, New England Regional Director, Chairman of the important Institute Judiciary Committee and member of many Chapter, Regional and Institute committees. As New England Regional Director (1952-1955), he organized the New England Regional Council and became its first President. He realized the council would fill an organizational vacuum in the structure of the American Institute of Architects, and it has. It has held three highly successful seminars and has done a great deal of committee work on matters of importance to the New England Chapter. He has served the Rhode Island Chapter, the New England Region and the Institute with vigor, efficiency and loyalty.

Although the Jury of Fellows is considering his nomination for other contributions to the profession, I would like to point out that his Hartford Park Public House Development in Providence has received national recognition as an outstanding contribution to public house design.

Phil Creer is currently Director of the University of Texas School of Architecture. He has moved from the smallest to the largest state. His achievements in teaching architecture and improving the profession, however, will be hard to top even by a Texan.

Gentleman:

I am pleased to hasten my endorsement of Philip D. Creer for advancement to Fellowship in the American Institute of Architects. Mr. Creer came to Providence, Rhode Island, I believe, in the year 1933. I was then Educational Director of Rhode Island School of Design, later Executive Vice President. A vacancy occured in the Department of Architecture and in 1934 I appointed Mr. Creer as Head of the Department, a post he held until his recent move to Texas University.

During that time Mr. Creer was not only a most successful teacher but he advanced the status of the Department steadily and with increased strength and importance until recently it was recognized and accredited by the Institute as one, if not the only, school unaffiliated with a University.

Mr. Creer demonstrated marked executive ability, a constant and continuing interest in progressive education programs of schools of architecture and at the same time a growing professional practice in the field itself.

The School Of Design, in 1940, acquired property and proposed construction of a new building to house an auditorium and the growing Division of Costume Design. I felt that as Head of our Department of Architecture Mr. Creer should be given the opportunity of designing the building. This was approved and the outcome was a successful structure, satisfying the complete program and specifications stipulated by the location, the demands of the School and the architectural relationship to the Georgian influence of the surrounding buildings. It was dedicated in 1941.

Mr. Creer was Head of the Department of Architecture of Warner Institute in Philadelphia from 1927 to 1932. He is now Director of the School of Architecture at the University of Texas.

Mr. Creer has been a member of the Rhode Island Chapter since 1934, and a Corporate Member of the Institute since 1941. He has served the Chapter as Secretary, Vice President and President. He served on the Chapter's Committee on Education, Joint

Committee of Architects and Contractors, Committee for the Preservation of Historical Buildings, and the Centennial Committee. From 1952 to 1955 he served as President of the New England Council and was also, during these years, a member of the Board of Directors of the American Institute of Architects as Regional Director from New England. In addition he has served on the National Judiciary Committee from 1952 to 1957, (Chairnan 1954-1956), and was Chairman of the Centinnial Subcommittee for the A.I.A. Commemorative Stamp.

Ever since his own graduation from the School of Architecture, University of Pennsylvania, Mr. Creer has been interested in the education of the student of architecture. Not a year has passed since that time in which he has not taught at a school of architecture - viz., Instructor in Architecture at the University of Pennsylvania; Head of Wanamaker Institute Department of Architecture; Head of Division of Architecture, Rhode Island School of Design; and presently Director of the School of Architecture at the University of Texas.

I am informed that the Rhode Island Chapter of the American Institute of Architects has nominated Philip Douglas Creer for advancement to Fellowship on the basis of "Education" and "Service to The Institute". When I became a member of the Board of Directors of The Institute in June 1953, Phil had already served one year on the Board.
