2. Describe the qualities of the nominees' design that are considered notable contributions to the advancement of the profession:

The success of the buildings designed by Kohn Pedersen Fox can greatly be attributed to the overall guidance of Gene Kohn and the organization he has built to support talented architects. He, along with his partners, set the goals and direction of design, which has resulted in many award winning buildings which have been lauded for their individuality, detail, sensitivity to the environment, use of materials and human scale.

Since the formation of Kohn Pedersen Fox in the mid-70's, their designs have continued to evolve seeking levels in design that are responsible, functional, and bring intelligent, sensitive architecture to numerous cities of America. They continue to explore within the context of an evolving architectural theory the issue of what a high rise building should be. Gene Kohn believes that a classically ordered and organized building helps to establish continuity among neighboring buildings and cohesion within a city. The values underlying the approach to design are those of traditional European urbanism where a strong wall of buildings along a street wall or square helps to shape public life. In most projects, the concern for urbanism is carried into the buildings themselves creating large, highly decorative interior spaces. Galleries, promenade decks and gardens are introduced successfully to give an internal circulation focus point and produce an atmosphere that promotes human interaction.

His talent for building an organization which can support the designers that the firm attracts and nurture them is his greatest actual contribution to the designs attributed to Kohn Pedersen Fox.

Since forming Kohn Pedersen Fox, Gene Kohn has made significant contributions to the field of architecture by guiding the firm to become one of the strongest in the United States, both nationally and internationally recognized. He has created a very special firm and provides outstanding management and design leadership. The firm strives to achieve the very best for every project regardless of size. By combining management techniques, cost control, scheduling and production capabilities with intellectual and aesthetic vigor, Kohn Pedersen Fox produces buildings that are both cost efficient in today's highly competitive market and ambitious in design.

To accomplish this goal, the firm has developed a team approach to design and production. At the outset, each project is assigned a "core" team of lead designers, managers and planners. This same team follows the project all the way through construction with additional staff added during the development and production phases, but the same people who work on program and design, do working drawings and supervise construction. The purpose of the team is to assure continuity which is not possible with the more usual assembly line approach, especially on fast-track projects which account for most of the firm's work. Kohn Pedersen Fox has gained its strength in having working partners - partners who actually design and produce buildings.

Gene Kohn believes that one of the most important members of any project team is the client especially during early planning, design development and budgeting phases. He encourages client participation, exploring many options at each decision point and then, with the client, chooses one with which to proceed to the next level of refinement.

The partners maintain an "open door" policy regarding the staff, which is reflected in the design of the Kohn Pedersen Fox offices. The staff is viewed as the firm's greatest asset. It is the concern for the employees and working with them on a one-on-one basis which has been responsible for assembling the talent who have designed some of the finest buildings and made tremendous contributions to the urban fabric of many cities.

To date, Kohn Pedersen Fox has completed 22 projects, (many award winning) and has major projects in some 14 states. By early 1987, they will have completed 31 major projects in 20 cities. The client list includes many of the major corporations and developers in the United States and three British clients. The firm has a history of designing several projects for the same clients including: nine projects for the American Broadcasting Companies, five for Reliance Development, and four for both Urban Investment and Development, and Lincoln Properties.

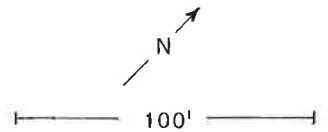
FLOOR 35

GROUND FLOOR PLAN



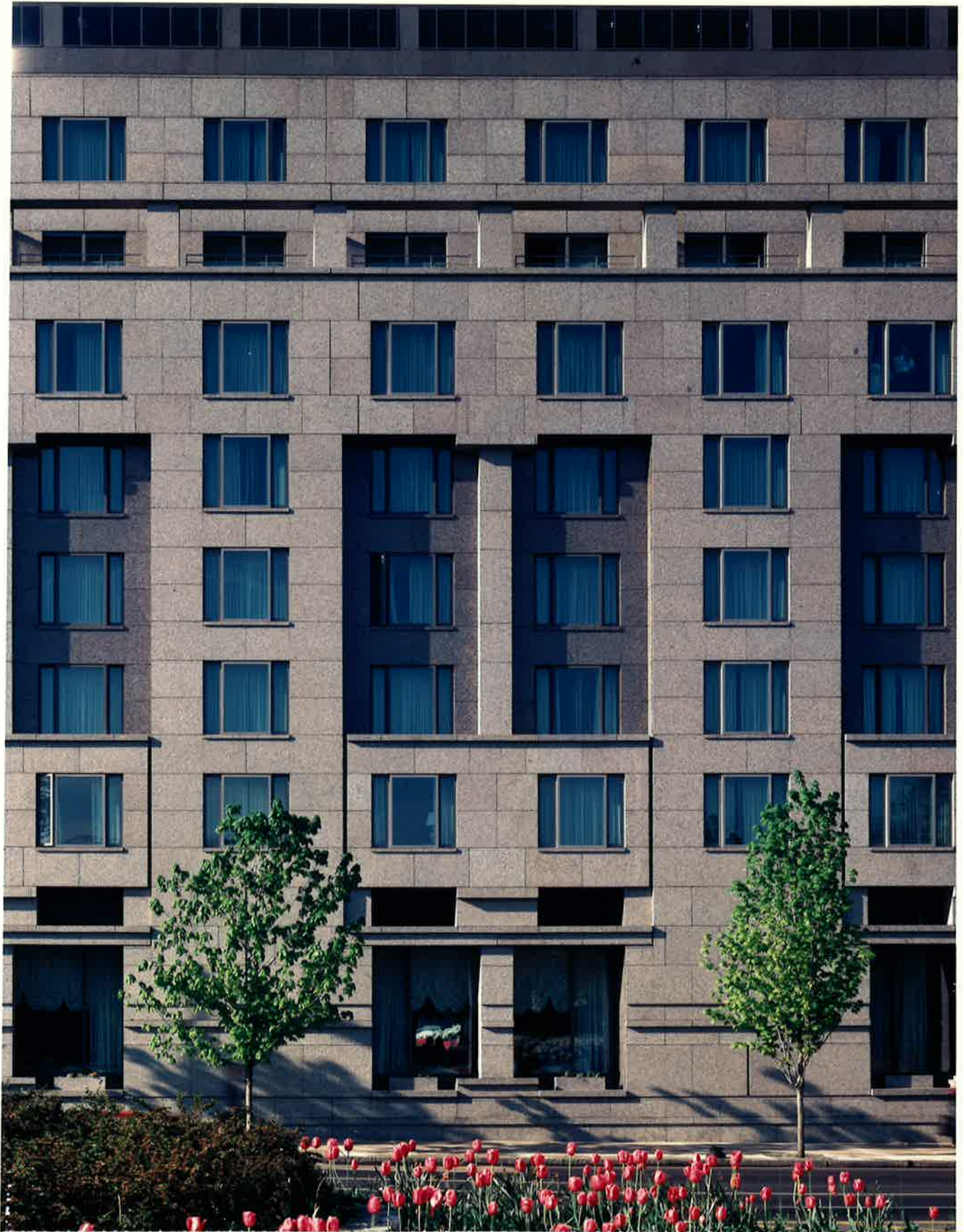

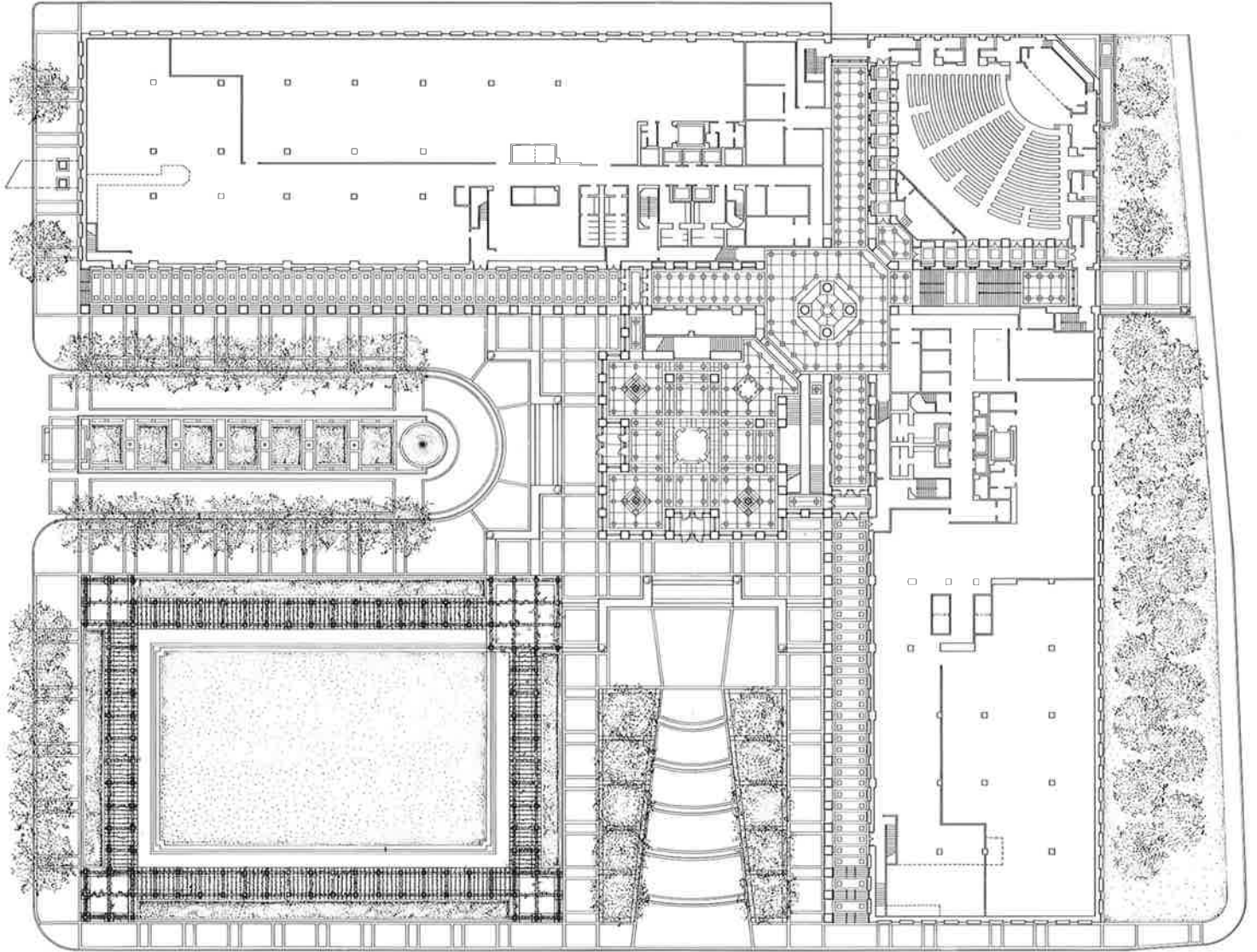

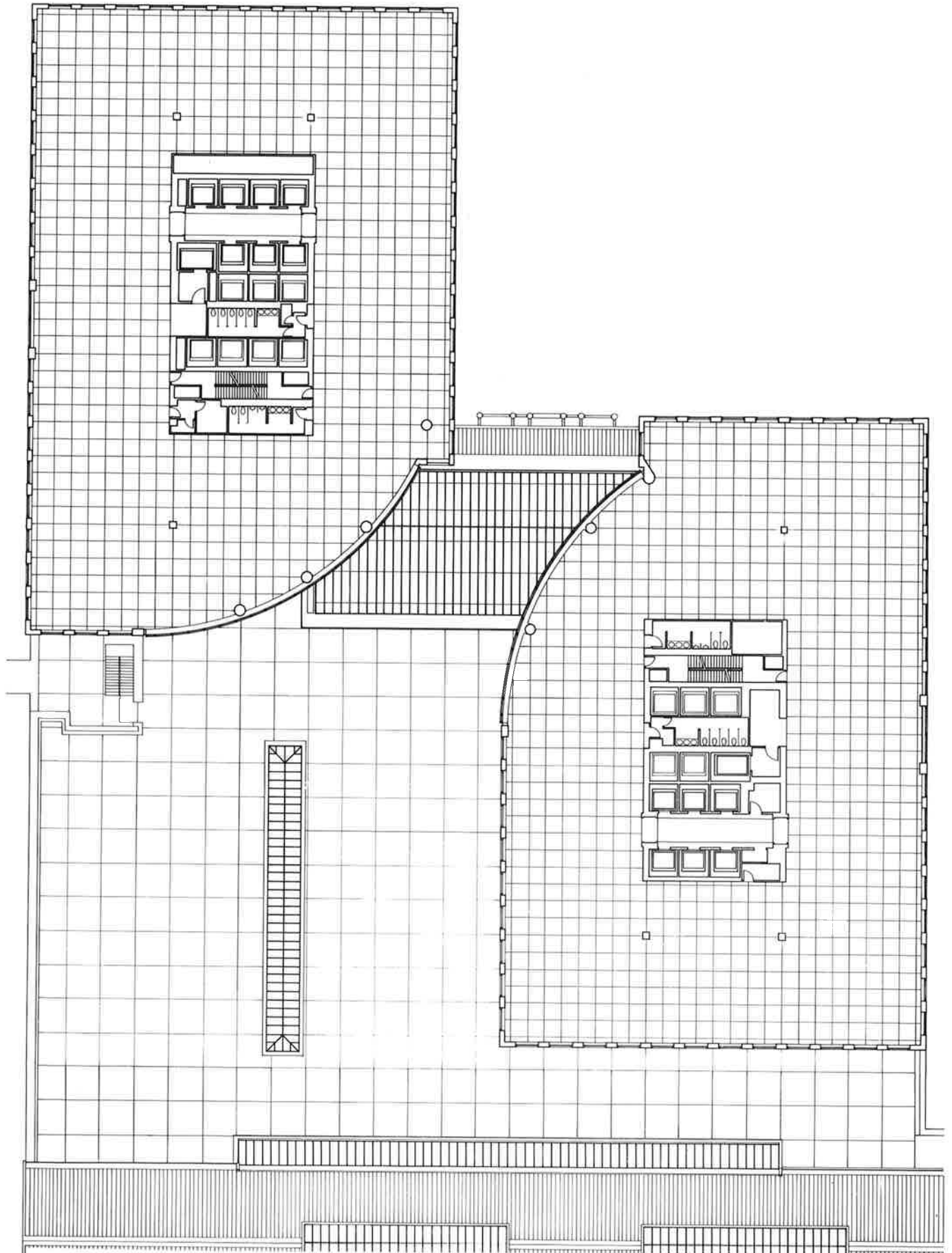
GROUND FLOOR PLAN
