## DETAILED EXPERIENCE RECORD TED ENGLEHARDT - ARCHITECT

### EDUCATION AND TRAINING RECORD

W. H. Sears, Architect, Chattanooga, Tennessee: May 1913 to September 1913

Entered office doing office boy work, blue printing, errands and receiving instruction in tracing and drawing in a manner similar to apprenticeship.

Barnwell & Jones, Architects, Chattanooga, Tennessee: May 1914 to August 1914

Same as above, but more responsible work.

Charles E. Bearden, Architect, Chattanooga, Tennessee: August 1914 to October 1917

I was placed in this office under an agreement between Mr. Bearden and my father that in return for such help as I might be in his office, I was to receive the foundation training in architecture. Was only employee in office doing the general professional work of a small architectural office. Here I worked summers and after school hours until I completed high school in May 1917, then I worked full time until October 1917 when World War I caused Mr. Bearden to close his office. Mr. Bearden too, particular interest in planning my school work and in guiding my drawing and reading along channels most to my benefit. This interest and guidance continued for many years after I left his office. Under his direction, at one time or another, I did practically all the work of an architect in average practice. As these were not busy years he gave freely of his time, allowing me plenty of time to do my work thoroughly. He especially stressed special design and analytic problems similar to Beaux Arts work. Among the problems we studied was a plan for the Australian Capitol City, Canbrerra, and a plan to re-develop a blighted section of our home city. These were our earliest efforts at town planning and slum clearance. I also made blue prints, typed specifications and handled personally the planning of small residence and store remodelling jobs. The office did considerable public school and textile mill work.

Semet Solvay Company: Draftsman October 1917 to March 1918

Draftsman and rodman. Construction of coke ovens and byproducts plants, Alton Park, Tennessee, and Sheffield, Alabama. General industrial drafting and groups of houses for company labor.

Valuation Bureau, Interstate Commerce Commission: March 1918 to February 1921

Junior architect (by Civil Service Examination), valuation of railroad buildings, making quantity surveys of labor and materials. Received in this work good foundation in the principles of construction cost estimating and valuation work, doing considerable travel also.

### Construction Work:

Because of my need for more construction experience in my education program, I left the government, and from February 1921 until March 1922 I spent doing general construction work for builders on concrete and steel construction, learning by doing. I kept the material and labor costs on various jobs in Florida and Alabama, for J. J. McDevitt in Pensacola, Florida, on high school buildings; worked as draftsman for George Rogers in Mobile, Alabama; as timekeeper and labor foreman on church building for William Beavers, Bradenton, Florida, Builder. Then I returned home to resume my architectural work.

### DRAFTING, DESIGN AND INSPECTION PERIOD

R. H. Hunt Company, Architects, Chattanooga, Tennessee: March 1922 to August 1927

General draftsman on sketches, working drawings, specifications and supervision of construction. I had progressive responsibility in an office doing a good volume of work over the South. Most of the work was on school and church buildings. Several of the South's largest churches and college groups, as well as public schools, were done in this office. Among these were Baylor College, Waco, Texas, Bluefield College, Bluefield, West Virginia, Mississippi College, Louisiana State University, Dallas First Methodist Church, Tulsa Baptist Church, large public schools in Chattanooga, Tennessee, Denton, Texas and Texarkana, Arkansas. Had charge of many projects as job captain. Also devoted much time and study to structural problems, including concrete design and inspection. In 1926 took several months' leave of absence to go to California to observe new uses and methods of construction.

Resigned in August, 1927, to accept an opportunity to work on design of Cove Creek Dam which was later built with few changes by T. V. A. as the famous Norris Dam.

U. S. Army Engineers: August 1927 to January 1928

Tennessee River Survey: Worked as draftsman on design of power houses and dams in the Tennessee River. Upon completion of the sketch plans I resigned to become Cith Plan Engineer at Chattanooga, Tennessee.

City of Chattanooga, Tennessee: January 1928 to March 1933

In responsible charge of street widening program and construction of miscellaneous buildings, bridges, etc.

My duties included making of preliminary surveys and supervision of detailed surveys, estimates of costs, quantity surveys, plans and specifications for street structures and alterations to buildings in connection with improvement projects.

Was Secretary to Condemnation Board, negotiated land and damages. Was member and Secretary of City Planning Commission. In this capacity I represented the City in zoning approximately twenty square miles of newly annexed territory.

In 1928 I qualified by a five-day written examination before the Tennessee Board of Architectural Examiners as a registered architect. I then actively began the practice of architecture, continuing also as City Plan Engineer. Among the successful buildings planned in my office were a large apartment building, The Jefferson, (the first in the city using bar joists and light concrete floor slab). I also planned and supervised construction of several city buildings, including a workhouse, two public bath houses and swimming pools, several park buildings, three incinerator buildings and the city airport terminal (a pioneer in this field at the time, 1929). In this period I directed the work of from twenty to eighty-five engineers and draftsmen.

Depression Jobs: March 1933 to September 1934

This being the depth of the 1930 depression, the City Plan Office was closed, and on failure to get enough work to continue operation of my own architectural office, I went with John C. Vance Company designing and selling steel specialties on salary and commission. Commissions were not forthcoming and I contracted to build several CCC camps in the newly established Smoky Mountain National Park in North Carolina. These camps presented many problems because of the remoteness of the sites and scarcity of competent labor.

I returned to Chattanooga to design and construct concrete culverts and retaining walls for D. E. Brown Construction Company. Insufficient work led me elsewhere.

### FEDERAL GOVERNMENT

Office of the Supervising Architect September 1934 to June 1939

Associate architect in U. S. Supervising Architect's Office. Worked in scale drawings groups preparing plans for many public buildings, full-size detail group, and in the space allotment office. I was in responsible charge of preparation of plans for post offices, coast guard stations, legation buildings and marine hospital buildings. Captained preparation of working drawings for several large Federal buildings, such as the Railroad Retirement Building and Washington National Airport. Prepared under direction of N.C.P. & P. Commission a plan for development of the "Southwest Triangle" in Washington, which now includes Social Security, Census and other Federal Buildings.

### Public Housing:

F.W.A. Public Buildings Administration June 1939 to June 1941

Defense Housing Program. Developed site plans and Housing units for many projects under "big name" associates, notably Linda Vista, San Diego, California, Aberdeen Proving Grounds, Maryland, Fort Knox, Kentucky, etc.

United States Housing Authority (F.P.H.A.) June 1941 to January 1945

Project Planner. Defense and war housing in Washington, New York and San Francisco Regions. In responsible charge of development of projects from site selection, planning, construction and management of war housing in Baltimore, Maryland, Norfolk, Virginia and Charleston, West Virginia, also San Francisco, California. Employed and supervised architects and engineers and awarded contracts.

Federal Public Housing Authority - General Field Office January 1945 to November 1946

Operations Adviser in Washington, D. C. Construction of temporary veterans! housing projects and management adviser on permanent slum clearance and war housing projects. Administrative and budget work added to technical work.

National Housing Agency, Office of Expediter November 1946 to March 1947. Salary \$7100.00 per year

Preparing, analizing and negotiating market guarantee contracts with prefabricated housing manufacturers. Not satisfied with the nature of this assignment I resigned from government work.

### PRIVATE CONSTRUCTION

Burnap-Owens Construction Company, Washington, D.C. March 1947 to September 1947

Left office of Housing Expediter to become construction manager with offices in Charleston, West Virginia and Washington. Contractor's manager on work at University of Maryland, Gettysburg College and Lebanon Valley College, Annville, Pa.

### ARCHITECT

In October 1947 I resumed the private practice of architecture as an associate in the firm of Proctor and Englehardt, Architects, 8616 Georgia Avenue, Silver Spring, Maryland. In 1951 Mr. Proctor retired because of his health. I assumed the work of the firm. Have continued the practice as a small suburban architect doing the general run of work coming to such an office, notably considerable housing and commercial but no political work.

# J. T. Englehardt, SOwned Own Firm, Of Architecture

J. Ted Englehardt, 82, a retired architect who designed a number of buildings at the University of Maryland, including the Denton Hall complex of dormatories, died Saturday at Holy Cross Hospital in Silver Spring following a stroke.

Mr. Engelhardt was born in Chattanooga, Tenn., and became an architect there through apprenticeship. He was licensed in Tennessee and was in private practice there until 1934, when he moved to Washington and joined the government.

He went to work in the Office of the Supervising Architect in the Treasury Department. Among the structures he helped design was the the terminal of National Airport.

In 1949, he left the government and started his own firm, J. Fred Englehardt & Associates. He operated it until 1977, when he retired. He lived in Silver Spring.

Mr. Englehardt was a member of the American Institute of Architects; and was certified to practice in Maryland, Virginia, West Virginia and the District of Columbia, in addition to Tennessee. He also was a member of the Silver Spring Rotary. Club and a former member of the Silver Spring Board of Trade.

Survivors include his wife, Mary Z. of Silver Spring, two sons, J. Ted Jr. of Granville, Ohio, and Dan T. of Fort Sumner Hills, Md., and five grandchildren.
