Dear Mr. Lovell:

This is the first opportunity to respond to your letter of September 7th:

We find from our records that your membership lapsed on December 31, 1944, at which time you owed for Institute dues for the years 1943 and 1944 in the total amount of \$40.00.

When a former member wishes to apply for readmission, it is not necessary for him again to fill in an application form. A letter addressed to The Secretary of The Institute, requesting readmission, and stating that the applicant is a practising architect, is sufficient. Such letter should be accompanied by check for any outstanding Institute dues, plus \$25.00 - \$5.00 of which is for the readmission fee, and \$20.00 for one year's Institute dues in advance which are the current fees. In 1946 the admission fee and annual dues will be increased.

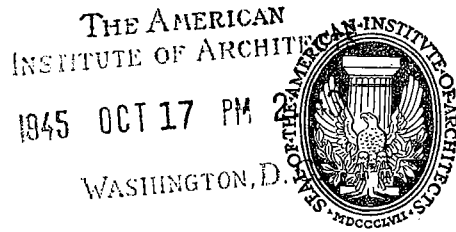

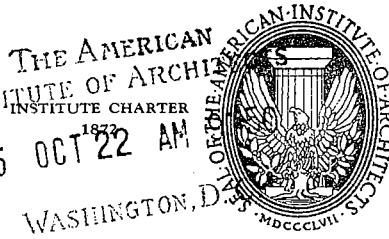
