

It has given me great satisfaction to participate in the nomination of Louis Bancel LaFarge for advancement to fellowship in the Institute. This both because of the unique and outstanding quality of his architectural design and the great service he has given to the Institute and to the public.

Louis LaFarge is a designer of unusual freedom and individuality. His work has unique charm and elegance that is completely free of pretense or spectacular show. His conceptions are his individual, personal expression of purpose, place, and client's needs and requirements. Their design is never bound by the restriction of style, past or even modern. His buildings are created with distinction and fine feeling to serve a distinctive type of living or activity, and to fit into and unite with their surroundings. They belong and are part of their environment and setting, and the function they serve. In this sense they are thoroughly contemporary.

The Villa at Cannes exemplified this. It is delightfully Mediterranean in character, but apes no past or present-day formula or style. It is built of native material but with freedom that is contemporary in expressing present-day living requirements. It has a simple elegance all its own that superbly fits its steep sloping semi-tropical site and landscape, and the background of distant hills.

The two American houses presented are equally fine settings for gracious living, but naturally quite different in character, as appropriate to New York and New England setting. The Stillman home, which is the earliest building, shows the influence of Colonial, but it, like all of LaFarge's work, has distinct individuality and freedom of design.

The Caneel Bay Resort is a charming background for recreation and living in the tropics. It is simple and straightforward, but delightful in its use and organization of material and variety of motifs.

The two schools presented have superb elegance and fitness of design, form and appearance, in spite of their extreme simplicity and functional openness. These unpretentious but distinguished buildings are the work of an unusually talented and distinguished architect.

Louis LaFarge has served the New York Chapter with ability and devotion for many years in various offices and on many committees. The last two years as President he has been an able but tactful leader.

LaFarge's achievements in public work on committees of many other societies of architectural or allied arts has been of service to the profession and the Institute.
