#### Achievement in Design

Mr. Sippel's professional career has spanned more than three decades with Deeter Ritchey Sippel and its predecessor firms, during which time he has directed the planning, design and execution of a broad spectrum of projects.

Several of the projects designed or influenced by Mr. Sippel have played an important role in shaping Pittsburgh's landscape and are familiar sights to most residents. Included among these are the City's two professional sports complexes, area health care facilities, corporate structures and buildings on the campuses of the area's two largest universities. 2. Describe the qualities of the nominee's design that are considered notable contributions to the advancement of the profession:

During a professional career spanning more than thirty years as a designer, principal in charge of design, and president and chief of design, Mr. Sippel has planned and designed major projects of significant importance. These projects have been executed for civic and governmental organizations, universities, hospitals and corporations. His work has been marked by a sensitive siting of structures, a straightforward sequence of space arrangement, unity in the massing of elements and the achievement of scale through the proportion of openings in the facade. The result has been distinctive architecture of timeless expression.

Many of the projects Mr. Sippel has participated in have been unique in nature and marked by innovative design solutions. From this broad background of projects, the following five examples illustrate key contributions to the advancement of the profession:

The Pittsburgh Civic Auditorium, with the largest retractable roof in the world, is a project Mr. Sippel was extensively involved with in the early stages of his career. The multi-purpose facility is used for many types of events, but was designed with the stipulation that the auditorium roof must open for concerts. The completed facility incorporates a 415 foot diameter dome with eight leaves, two of which remain fixed and six of which rotate around the center.

One of the main challenges in designing Three Rivers Stadium was to provide a seating arrangement that would satisfy the needs for both baseball and football games. The conversion is accomplished by moving two banks of 4000 ground level seats between first and third bases which then become the 50-yard line seats for the football field.

The Westinghouse Electric Corporation Nuclear Center Office Building incorporates many energy-saving features including heating by lighting with no heat source. The project received the first Owens-Corning Fiberglas Energy Conservation in Building Design award.

The design of the Benedum Hall of Engineering at the University of Pittsburgh took existing concepts in laboratory design and consolidated these concepts into a major engineering structure. The project serves as a prototype for college research facilities to the present day.

The design of the Jefferson Center Hospital reflects the philosophy of a progressive client determined to evolve a better and more efficient hospital management system. The building and program advanced several new concepts in hospital design, including decentralized administration, primary nursing, a central triage area and materials handling.

3. List the significant awards, honors and recognition accorded by the Institute and other professional, governmental or civic organizations for the nominee's work in design:

Mr. Sippel's achievements in design began during his student years at Pennsylvania State University. Though his college education was interrupted by service in World War II, he resumed his studies and achieved distinction in his architectural program. While at Penn State, Mr. Sippel was awarded the following:

While at Princeton, Mr. Sippel was awarded the prestigious Paris Prize in Architecture (1950) for his design of a banking facility. The award of the Paris Prize fellowship enabled Mr. Sippel to study under the late Louis Kahn at the American Academy in Rome and at the E'cole des Beaux Arts in Paris, as well as to travel extensively.












First Floor
