THUMB-NAIL SKETCHES

Leonard Schultze, F.A.I.A.



Greatest hotel expert in the country! Nothing he doesn't know about eating, drinking and sleeping! And why not? With over fifty hotels tucked beneath his belt! Grey-haired, deep bass voice, distinguished in appearance, Len Schultze is in all respects a swell guy. He was with Warren and Wetmore for years,

in charge of railway stations and hotels, with side trips into the fields of apartment houses and hospitals. He attended the College of the City of New York and fit nobly in the Spanish-American war.

Most of his Spanish fighting was done in Cuba, but we suspect that he had his left eye out for business as well as bumping off the Aficionados, for as soon as the war was respectably over, he put over the Seville-Biltmore Hotel in Havana and the Playa Bathing Beach nearby. What we mean to say is that even where the bullets were thickest, Len was always the business man.

His hotels include the Lexington and Pierre in New York, Miami-Biltmore in Miami, the Breakers in Palm Beach, and of course the Waldorf-Astoria in New York.

In that caravansary he was surrounded by untold difficulties from the beginning. First of all, every luxury had to be included (hard luck!—at six percent!); railroad tracks were running awry under the site, thus making the steel layout a very devil in itself; a short time-to-finish schedule and a cubic foot upset cost had to be watched incessantly; the structure was to be divided into an apartment house and a transient hotel, each with its own entrance and banks of elevators—world without end of troubles.

There are 2200 bedrooms in this hotel of 22,000,000 cubic feet, so you can readily see that the average size of each room is inordinately high. Each bedroom is separated from the corridor by a foyer, on account of so much noise made by delegates to conventions. There are at least fifty suites, all different. The bewildered architect made three-quarter scale details of every room and every corridor in that building—covering a big block, forty-two stories up.

Then when Len got to the entertaining floors he hauled off and did incredible stunts. Besides the Grand Ball Room there are three other ball rooms adjoining. By some necromancy performed by this old witch, each ball room has its own serving pantry and can be rented to a separate organization all at the same time, without the other fellow



The Waldorf-Astoria Hotel was an especially difficult job because of the fact that it was built entirely over the railroad tracks and received all of tts heat, light and power form outside sources and has a very small percentage of basement space.

The Breakers Hotel in Palm Beach is notable form the construction standpoint in the fact that it was built on made ground and the terrace to the water side is constructed so that one side of it becomes a sea wall which acts as a buffer and a protection for the entire Hotel structure which is an example of the use of reinforced concrete and stucco.

The Parkway Villi ge is a large scale Housing Development on a 40 acre piece of property in which the dwelling untis are gither two or three stories high. This is one of the first of small housing untis which has been built to be nearly absolutely firefproof. In these buildings, for the first time, precast long span vacuum concrete slabs have been employed with no plaster ceilings and roofs that are either fireproof or fire retrding and in order to fit this construction to the type of the buildings, the entire structures had to laid out on a modular system to correspond with the module necessary for the floor slabs.


