In the International field, Mrs. Smith has the happy faculty of getting on with our neighbors to the north and to the south, and through her fluency in Spanish she has been able to communicate her ideas to our Latin American neighbors.

The initial project of Mrs. Smith*s with which I am familiar was the exhibit she prepared in Montreal, Quebec, in 1940. This exhibit was extremely well received, and her interest in this type of exhibit has remained undiminished. Her most recent exhibit was, as you know, sent to Moscow by the Union Internationale des Architectes.

In 1944 Mrs. Smith travelled extensively in South America as a Guggenheim Fellow, and likewise lectured at the University of La Paz, Bolivia Her understanding of the Latin American people, their language and customs, makes her a peculiarly effective interpreter of her architectural ideas to our neighbors to the south.

In summation, Mrs. Smith¹s tact, understanding, knowledge, and her professional ability to see and interpret her client¹s needs, and express for them what they are searching for, would all, it appears to me, be qualities which would make her eminently qualified to be elected a Fellow of the Institute

Gentlemen:

I am in receipt of a letter from Mr. Louis Justement, advising that Chloethiel Woodard Smith has been nominated for fellowship in the American Institute of Architects and asking that I send you my endorsement of this nomination.
