I refer especially to the Club Union in La Paz, Bolivia, a city normally lacking in architectural refinement and charm. Mrs. Smith's work there offers an especially bright spot in the otherwise drab architecture of that city.

Her hospitals at Guajara Mirim and at Riberalta in the primitive Bolivian hinterland are simply and functionally designed and cleverly contrived to utilize local wood and clay products of native manufacture to the greatest extent.

Perhaps among her most interesting and important buildings in Latin America are the United States Embassy office building and the Ambassador's residence in Asuncion, Paraguay. This large project, just now approaching completion, reflects the

careful/

careful study and planning that could only be rendered by an architect sensitive to Asuncion's unique and isolated geographical situation and familiar, as are few architects, with the peculiar demands of both official and private life in the United States Foreign Service.

The profession may well be proud of Mrs. Smith and her work and to honor her with a Fellowship at this time would be most fitting.

Gentlemen:

It gives me great pleasure to endorse the nomination of Chloethiel Woodard Smith for advancement to Fellowship on the basis of her achievement in design and Service to the Institute. This nomination by the Executive Committee of the Washington Metropolitan Chapter is well deserved.

Chloethiel Woodard Smith's design has been particularly noteworthy in the field of large-scale housing. The outstanding character of her design achievements in the Washington area is exemplified by her latest work, forming part of the Southwest Redevelopment Scheme (Area B). The striking tall apartment buildings that form the main feature of this group is an attractive, straightforward structure. Related to it will be large groups of row houses, spaciously arranged and separated from the high-rise building by a large open space with trees that have been carefully preserved. The model which was exhibited at the Brussels Fair shows the completed arrangement. The individual apartments in the dominant structure, which I visited, is particularly well planned and spaciously organized with broad and interesting outlooks. Such practical matters as adequate, well-placed parking have been carefully developed.

Chloethiel Smith's education has well prepared her for the important work she is doing in large-scale housing and planning. After receiving her Bachelor's degree (with honors) and her Master's degree in architecture, she studied under Henry Wright in 1933. She was deeply influenced and inspired by this great leader in modern planning.

Housing and planning have been her greatest interest. But she has created important buildings in other fields, not only in the United States but in South America. In Bolivia during the Forties she designed a hospital in Guayamerin, and a Club Union in La Paz. At the same time she was professor of Architecture and City Planning in Universad Mayor de San Andres, La Paz, Bolivia. She afterwards broadened her own architectural education by studies throughout South America on a Guggenheim Traveling Fellowship.

The same full-hearted energy, drive and enthusiasm that goes into her architectural work forms the basis of her service to the Institute. Among her latest achievements in this field was her organization of the "Cities - U.S.A." exhibit sent to Moscow by Union Internationale des Architectes last summer. She has served the Washington Metropolitan Chapter since 1935 in making constructive studies and reports related to the National Capital Area. In 1947-52 she was active as a member, and in 1952-53 was Chairman of the A.I.A. International Committee.

I strongly recommend that Chloethiel Woodard Smith be advanced to Fellowship on the basis both of her service to the Institute and thus to the public, and because of her attainment in design.
