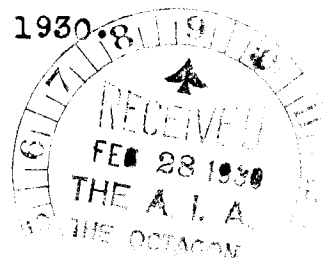

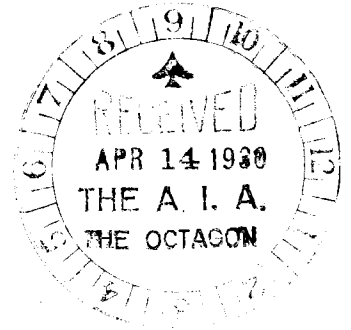

The kindly good wish and generous offer touched me greatly, and I accept them both with a feeling of gratitude.

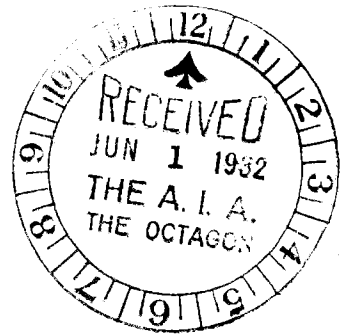
The past year has not been an easy one for me in many ways, so things like this, help me to forget the trying experience through which I have been.

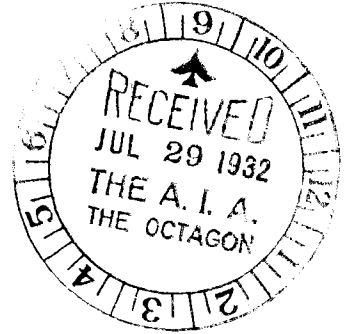
