He has edited 22 such series to date and the Association schools are using the slides in their instructional programs.

In addition to his committee work in the Association, Frofessor Sargent has contributed important articles on a wide range of subjects in publications of interest to the construction industry. He has also served as secretary, vice president, and president of the Central New York State Chapter, A.I.A. and has been active in the New York Association of Architects and in the Syracuse Society of Architects.

His public service record is also an impressive one, having served as chairman of the Home Safety Committee of the New York State Health Department, as a member of the Zoning Board of Appeals and member of the Board of Education at Liverpool, New York, and in many other capacities. In my opinion, Professor Donald K. Sargent is most deserving of advancement to the Fellowship, and I recommend him for that honor without any reservation whatsoever.

This program was conceived by Mr. Sargent and executed by him almost single-handed.

The Structural Clay Products Industry, which I represent, conducted a survey a few years ago of the colleges to which these slide lectures have been sent, and we found that they were accorded a most enthusiastic reception by the teaching staffs.

Wr. Sargent has also served on the Jury of Awards of the Building Products Literature Competition, sponsored by the A.I.A.-P.C. Joint Committee, and his constructive criticism of manufacturers' literature has been most helpful to manufacturers in making their publications of greater value to the architect.

It was with much interest that I learned of the Central New York Chapter's nomination of D. Kenneth Sargent for advancement to Fellowship in the Institute. If it is not inappropriate, I should like to submit a word of my own regarding the services that he has performed, within my knowledge.

My work as Modular Coordinator is directed by the Joint Committee of the AIA and The Producers' Council, of which Mr. Sargent has been for a number of years a very active member.
