I take this opportunity to express my personal congratulations and good wishes.

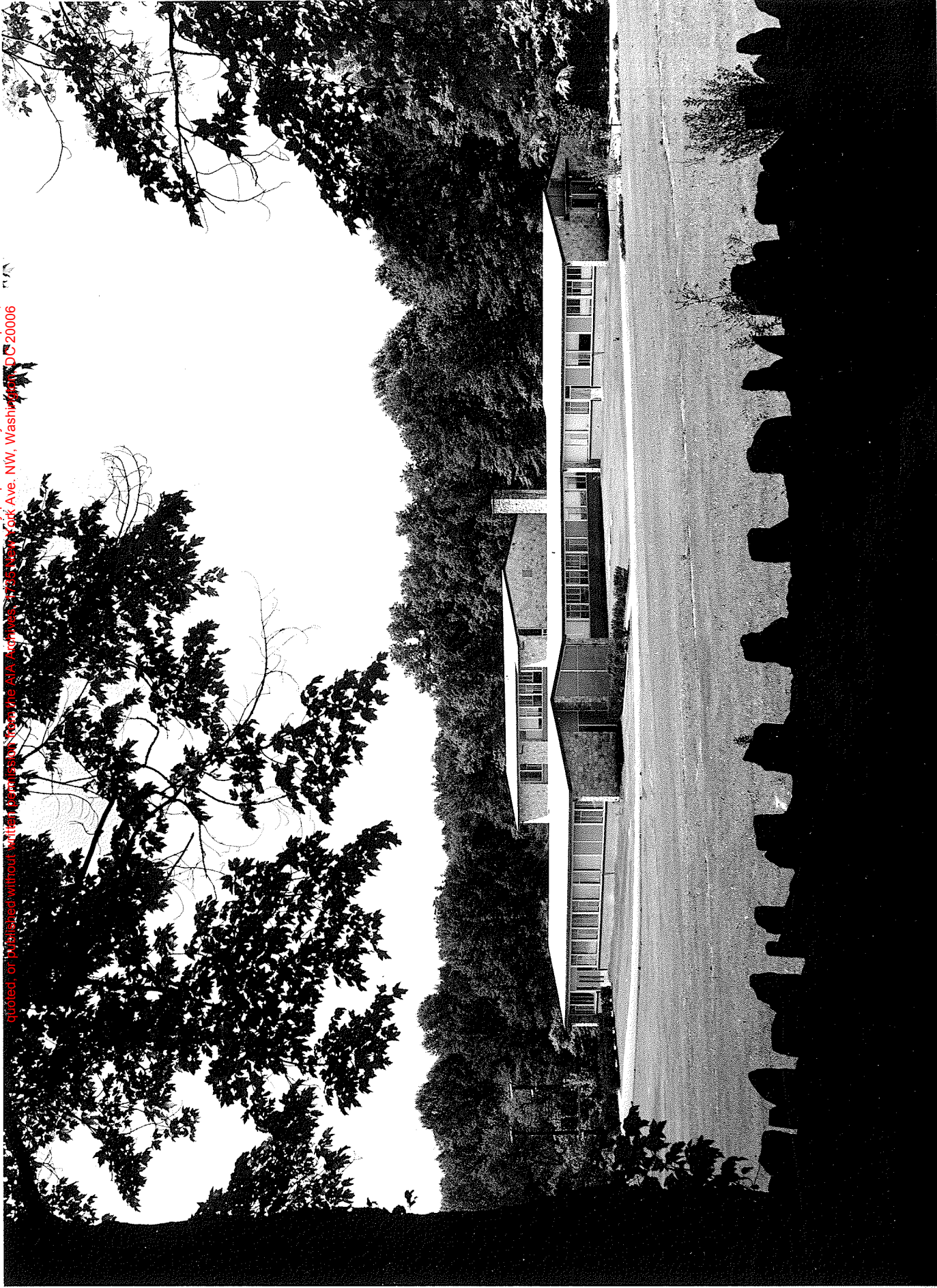
