Your inquiry relative to the citation of fellowship for your father has been referred to me to investigate as I am presently in charge of files.

Unfortunately, at that time there were no formal nomination papers for fellowship such as we have now, so that the record does not contain anything in respect to your father's activities. The nomination as made on the floor and recorded in the Proceedings is transcribed herewith for you.

In the biographical information submitted at the time of your father's death, we find that the Woodbury County Court House, Sioux City is listed as one of his principle works with George E. Elmslie associated. It might be that if we knew the date when the court house was constructed that it would be possible to find some reference to it in the periodical litera-I did check several books and scrapbooks on court houses but didn't find anything.

We regret we cannot give you the exact information you requested but hope that perhaps this will be of some assistance to you.
