#### Gentlemen:

This letter is written in support of the nomination of E. Todd Wheeler for Fellowship in The American Institute of Architects.

There is attached a folder entitled "Data on Nominee" prepared by the Committee on Fellowship of the Chicago Chapter, which will amplify and supplement the data included with Mr. Wheeler's nomination. C. Consultant on planning of hospitals and medical schools. This activity in itself is unusual, most consultants in this field having a background either as doctors or as hospital administrators. Mr. Wheeler, bringing to this work the experience of the architect, is making an important contribution to the planning of medical facilities. His success in handling projects of various types and sizes across the country is indicative of his unusual performance in the field.

In parallel to Mr. Wheeler's professional career, he has participated in public service to a very great extent. His work for the State of Illinois from 1950 to 1952 is an example of a public activity where an architect has gone into government life to improve the organization and management of a major public works program. His other activities in the Wilmette Planning Board, the Community Fund, the American Hospital Association, and other service agencies are additional evidence of his overall interest in serving the community.

I have personally known Mr. Wheeler in both areas in which he is being nominated for Fellowship: Design and Public Service. This firm has performed architectural services for projects which have been constructed under his technical and administrative guidance. These include a structure for the University of Illinois at the Medical Center, and a large hospital project for the State of Illinois when he was assisting the supervising architect of the State. In both of these projects, we had an opportunity to observe Mr. Wheeler's technical performance, energy and integrity, all of which are of superior quality.



#### Gentlemen:

I wish this to be the strongest letter I have ever written to you. If any man can ever be said to know another, then I can say that I know Mr. E. Todd Wheeler and endorse him for Fellowship in the American Institute of Architects with every means and thought at my disposal.

We have been close friends since high school. We were in partnership from 1936 until World War II. We continue to do work together as the occasion warrants. We continue to see each other at home.

Mr. Wheeler has made a unique spot for himself in the profession -- in effect, as an architect's architect... as distinguished from a consultant. He has genuinely improved the hospital work of the many offices with whom he has worked on hospital projects. I think it is correct to say that his gift is in programming and organization of problems even more than in the architectural design to implement these programs. Gentlemen:

It is my privilege to support the nomination of Mr. E. Todd Wheeler for Fellowship in The American Institute of Architects. Mr. Wheeler has made a very real contribution to our program and I am happy to give the Jury of Fellows a brief account of this activity which has engaged a considerable proportion of his time for almost three years.

In the fall of 1951 the Trustees of the United Mine Workers of America Welfare and Retirement Fund authorized the loaning of funds to the Memorial Hospital Associations of Kentucky, West Virginia and Virginia to enable these newly organized nonprofit corporations to construct and operate a network of hospitals in the coal fields of southeastern Kentucky, southern West Virginia, and southwestern Virginia. Shortly thereafter, I became the Medical Administrator of these three Associations. Our mandate was to build and prepare to operate ten general hospitals with a total of approximately 1,000 beds. Planning had extended little beyond the selection of certain sites for the hospitals when it became evident that it would be helpful to us to engage the services of an experienced consultant. Early in 1952, we selected Mr. Wheeler as our consultant and were happy to reach an agreement with him whereby he devoted approximately one-third of his time to our project for a period of over two years. Since the completion of our regular contract with him, he has continued to serve the Welfare and Retirement Fund as a consultant for the purpose of helping to supervise construction and to participate in the budgetary control process.

Aside from helping us with the selection of certain final sites for the hospitals, Mr. Wheeler's principal contribution during the early stages of our program was that of preparing a written program to govern the facilities to be developed in each of ten different general hospitals, ranging in size from approximately fifty to two hundred beds. While this program has been subject to some change since its original formulation, it has guided us and our three firms of architects throughout the construction program up to this date. As the architects undertook their assignments, Mr. Wheeler

has helped us with the process of coordinating the work of three firms of architects, with the review of schematic plans, with the review of preliminary plans, and, to some extent, with the review of final working drawings.

One of our problems concerned the method of carrying out the building program. With Mr. Wheeler's help, we decided to select a builder and carry out the construction program on a cost-plus-fixed-fee basis. Mr. Wheeler was of great help to us in effecting the careful selection of a reliable builder and in formulating a contract which would respect the rights and interests of the owner.

While I have mentioned the principal ways in which Mr. Wheeler has been of direct assistance to us, I have not dealt with countless smaller ways in which we have benefited by his advice and help over the entire construction period. His knowledge of the field of architecture has been of great value to us and of hardly less importance has been his unique experience in coordinating large projects involving a number of institutions and an integrated program. Mr. Wheeler brings to a task such as ours an almost unique experience of this kind which cannot help but result in direct and indirect benefits to the responsible agency.

As chairman for a number of years of the Reviewing Committee on health agency budgets of the Community Fund of Chicago, Mr. Wheeler contributed generously large blocks of time to a vital community activity. He helped with the distribution of more than a million dollars of community funds annually among some 30 hospitals, clinics, and other health agencies. His leadership, as chairman of the committee, was outstanding. He obtained effective committee participation. In this activity he displayed remarkable ability in analyzing program, as well as financial factors of the agencies to which the Community Fund allocated funds.

Mr. Wheeler is playing a leading part in the Committee on Hospital and Clinic facilities for the Medically Indigent of the Welfare Council's Health Division. As chairman of a sub-committee he directed the formulation of a tentative over all community plan for hospital and clinic facilities for the medically indigent to serve as a basis for detailed and full committee consideration. #### Gentlemen:

I am in charge of the budgeting operations of the Community Fund of Chicago. Mr. E. Todd Wheeler served as the Chairman of our Health Reviewing Committee and is at the present time a member of our central Budget Committee and of our Policy Committee.

I have been in charge of the budgeting of the Community Fund since its inception and have worked with many chairmen. Mr. Wheeler demonstrated a unique capacity for leadership in the Health Reviewing Committee. It is perhaps one of our most difficult fields in that we budget not only clinics and general health agencies but allocate toward the cost of a certain number of free beds in voluntary hospitals. The problems in this field are tremendous, and the scope is difficult for a layman to encompass. Although having a very good grasp of detail, he never became lost in the detail. Time and time again he pulled the attention of the committee back to over-all problems confronting the health field and showed the relationship of the specific situation we were confronting to the over-all problem.
